Penerbitan ini memaparkan perangkaan bagi perkhidmatan kesenian, hiburan dan rekreasi yang diperoleh daripada Banci Ekonomi 2016 bagi tahun rujukan 2015. Perkhidmatan kesenian, hiburan dan rekreasi ini merangkumi aktiviti kesenian, hiburan dan kreatif; aktiviti muzium, hiburan dan kebudayaan dan aktiviti sukan dan rekreasi. Perkhidmatan ini meliputi semua industri dalam Seksyen R yang dikelaskan di bawah Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 Ver. 1.0, selaras dengan Piawaian Klasifikasi Industri Antarabangsa bagi Semua Aktiviti Ekonomi (ISIC), Semakan Ke-4, 2008. Kali terakhir banci ini dijalankan adalah pada tahun 2011 bagi tahun rujukan 2010.

Data utama yang berkaitan dengan nilai output kasar, nilai input perantaraan, nilai ditambah, bilangan pekerja, gaji & upah dan nilai harta tetap dilaporkan dalam penerbitan ini. Maklumat pekerja mengikut kelulusan dan pemilikan wanita turut dipaparkan. Data tersebut boleh digunakan oleh agensi kerajaan, ahli ekonomi, ahli akademik, pihak swasta serta individu bagi tujuan membuat perancangan dan penggubalan dasar, analisis ekonomi, unjuran dan membantu merancang pembangunan perniagaan.

Penerbitan ini dibahagikan kepada tiga bahagian. Bahagian pertama memaparkan hasil penemuan bagi keseluruhan perkhidmatan kesenian, hiburan dan rekreasi. Aspek teknikal seperti skop dan liputan, konsep dan definisi serta pembolehubah utama yang digunakan diterangkan di bahagian kedua bagi memudahkan pengguna memahami statistik yang diterbitkan, manakala bahagian ketiga pula memaparkan jadual perangkaan terperinci.

PREFACE

This publication presents statistics on arts, entertainment and recreation services obtained from the Economic Census 2016 for reference year 2015. Arts, entertainment and recreation services encompass creative, arts and entertainment activities; museums, amusement and cultural activities and sports and recreation activities. These services include all industries in Section R classified under the Malaysia Standard Industrial Classification (MSIC) 2008 Ver. 1.0, in accordance with the International Standard Industrial Classification of All Economic Activities (ISIC), Revision 4, 2008. The last census was conducted in 2011 for reference year 2010.

Key data related to value of gross output, value of intermediate input, value added, number of persons engaged, salaries & wages and value of fixed assets are reported in this publication. Information on number of persons engaged by qualification and women ownership are also published. These data can be used by government agencies, economists, academicians, private sectors and individuals for planning and formulations policies, economic analysis, projections and to assist in business development planning.

This publication is divided into three parts. The first part displays the findings for the entire arts, entertainment and recreation services. Technical aspects such as scope and coverage, concepts and definitions as well as the key variables used are describes in the second part to assist users to understand the published statistics. Meanwhile, the third part provides the detailed statistical tables.

The Department gratefully acknowledges the co-operation rendered by the respondents as well as all parties who have contributed directly and indirectly in making this census a success. Every feedback and suggestion towards improving future reports is highly appreciated.

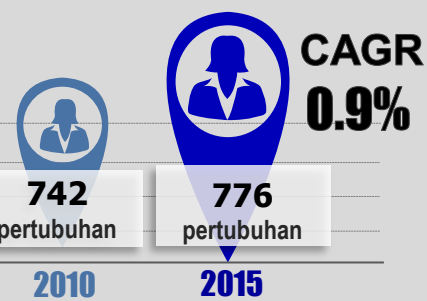

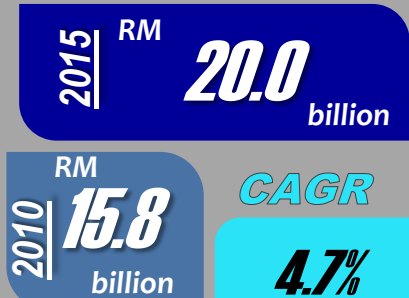

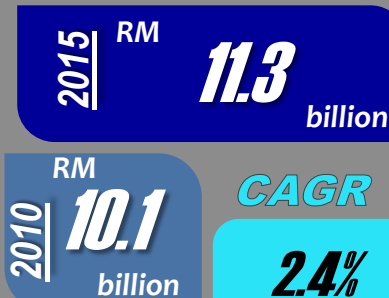

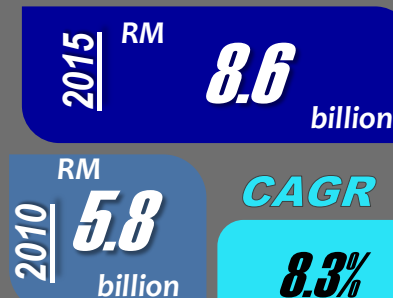

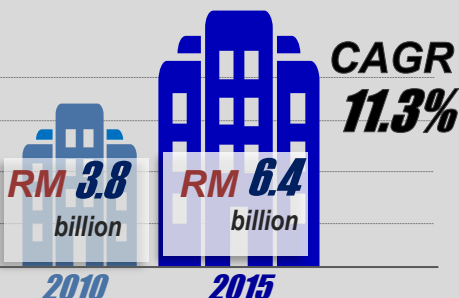

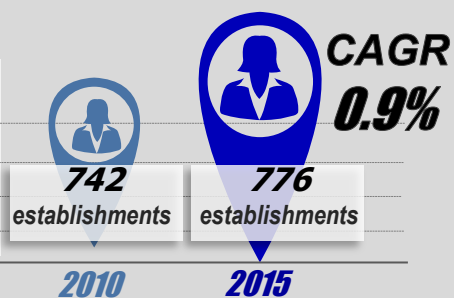

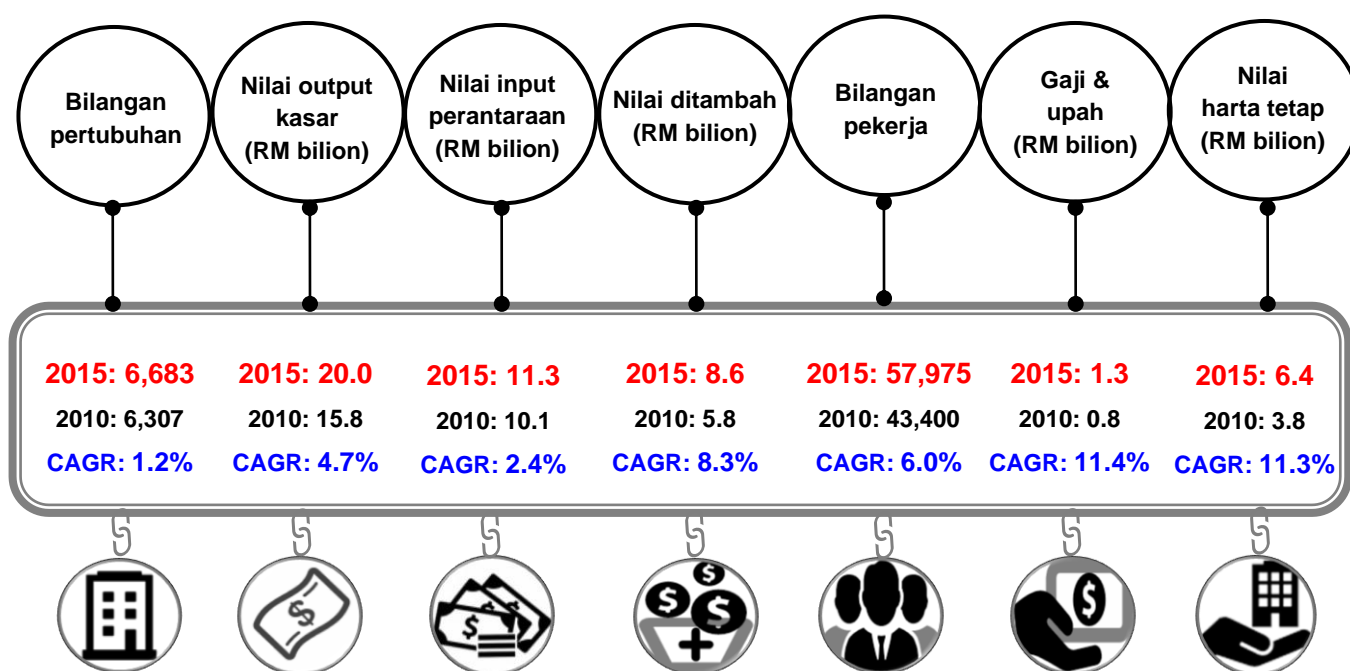
1. PENGENALAN

Penerbitan ini membentangkan perangkaan bagi perkhidmatan kesenian, hiburan dan rekreasi berdasarkan maklumat yang diperolehi daripada Banci Ekonomi yang dijalankan pada tahun 2016 bagi tahun rujukan 2015. Perkhidmatan kesenian, hiburan dan rekreasi merangkumi aktiviti kesenian, hiburan dan kreatif; aktiviti muzium, hiburan dan kebudayaan dan aktiviti sukan dan rekreasi.

2. PRESTASI PERKHIDMATAN KESENIAN, HIBURAN DAN REKREASI

Perbandingan perangkaan utama perkhidmatan kesenian, hiburan dan rekreasi antara tahun 2010 dan 2015 seperti di **Paparan 1**. Penemuan banci menunjukkan bahawa sejumlah 6,683 pertubuhan telah beroperasi pada tahun 2015. Jumlah output kasar yang dihasilkan adalah RM20.0 bilion, manakala nilai ditambah adalah RM8.6 bilion. Bilangan pekerja yang terlibat dalam perkhidmatan ini adalah seramai 57,975 orang dengan nilai gaji & upah yang dibayar berjumlah RM1.3 bilion. Nilai harta tetap bagi tahun rujukan merekodkan RM6.4 bilion.

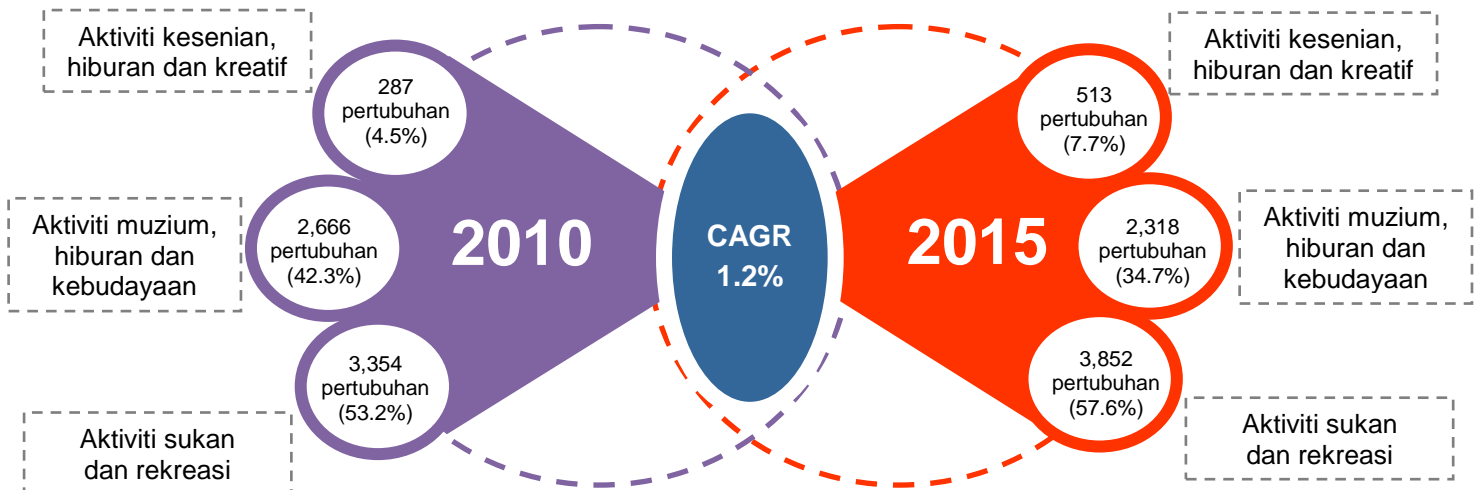
Paparan 1: Perbandingan Perangkaan Utama Perkhidmatan Kesenian, Hiburan dan Rekreasi, 2010 dan 2015



3. BILANGAN PERTUBUHAN

Pada tahun 2015, sejumlah 6,683 pertubuhan telah beroperasi dalam perkhidmatan kesenian, hiburan dan rekreasi berbanding 6,307 pertubuhan pada tahun 2010. Jumlah ini mencatatkan kadar pertumbuhan tahunan dikompaun (CAGR) sebanyak 1.2 peratus setahun. Aktiviti sukan dan rekreasi mencatatkan bilangan pertubuhan tertinggi iaitu 3,852 pertubuhan dengan sumbangan 57.6 peratus (seperti di **Paparan 2**). Ini diikuti oleh aktiviti muzium, hiburan dan kebudayaan (2,318 pertubuhan; 34.7%) dan aktiviti kesenian, hiburan dan kreatif (513 pertubuhan; 7.7%).

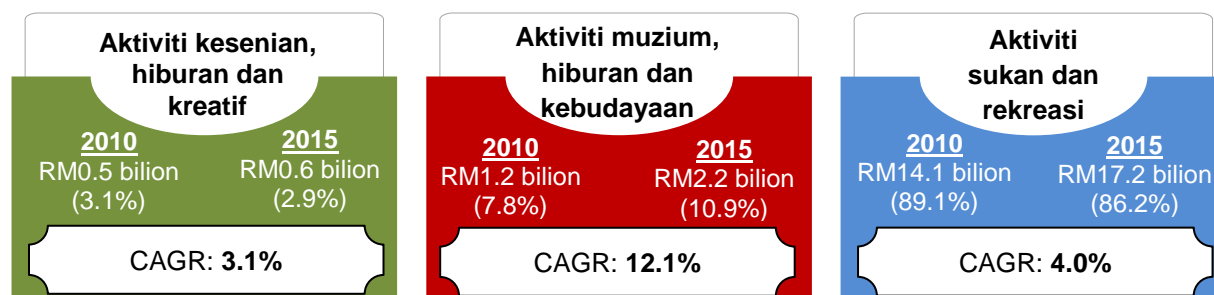

4. NILAI OUTPUT KASAR

Nilai output kasar yang dijana bagi perkhidmatan kesenian, hiburan dan rekreasi berjumlah RM20.0 bilion berbanding RM15.8 bilion pada tahun 2010. Jumlah ini mencatatkan CAGR sebanyak 4.7 peratus setahun. **Paparan 3** menunjukkan nilai output kasar mengikut aktiviti bagi tahun 2010 dan 2015. Aktiviti sukan dan rekreasi mencatatkan nilai output kasar tertinggi iaitu RM17.2 bilion dengan sumbangan 86.2 peratus, diikuti aktiviti muzium, hiburan dan kebudayaan (RM2.2 bilion; 10.9%) dan aktiviti kesenian, hiburan dan kreatif (RM0.6 bilion; 2.9%).

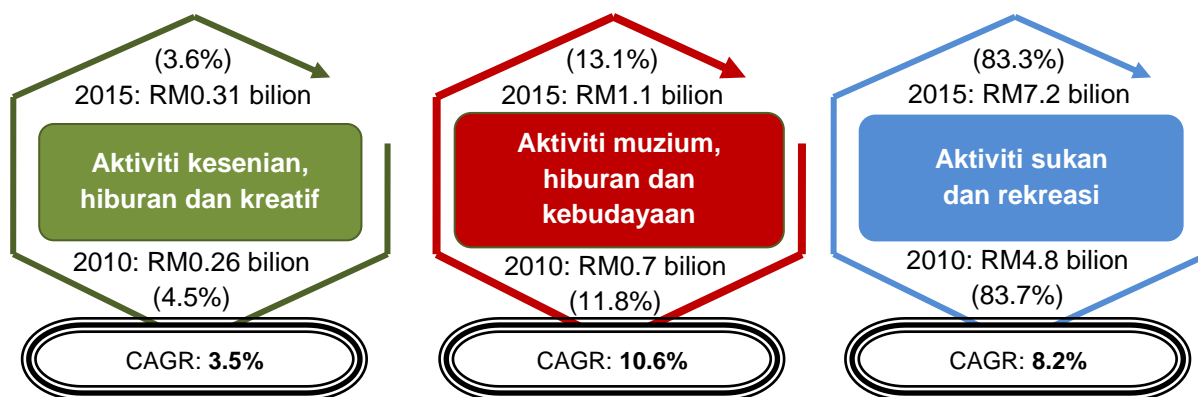

5. NILAI DITAMBAH

Nilai ditambah bagi perkhidmatan kesenian, hiburan dan rekreasi mencatatkan pertumbuhan tahunan sebanyak 8.3 peratus setahun kepada RM8.6 bilion pada tahun 2015 berbanding RM5.8 bilion pada tahun 2010. Selari dengan nilai output kasar, aktiviti sukan dan rekreasi merekodkan nilai ditambah tertinggi iaitu RM7.2 bilion dengan sumbangan 83.3 peratus, diikuti aktiviti muzium, hiburan dan kebudayaan (RM1.1 bilion; 13.1%) dan aktiviti kesenian, hiburan dan kreatif (RM0.31 bilion; 3.6%) seperti ditunjukkan dalam **Paparan 4**.

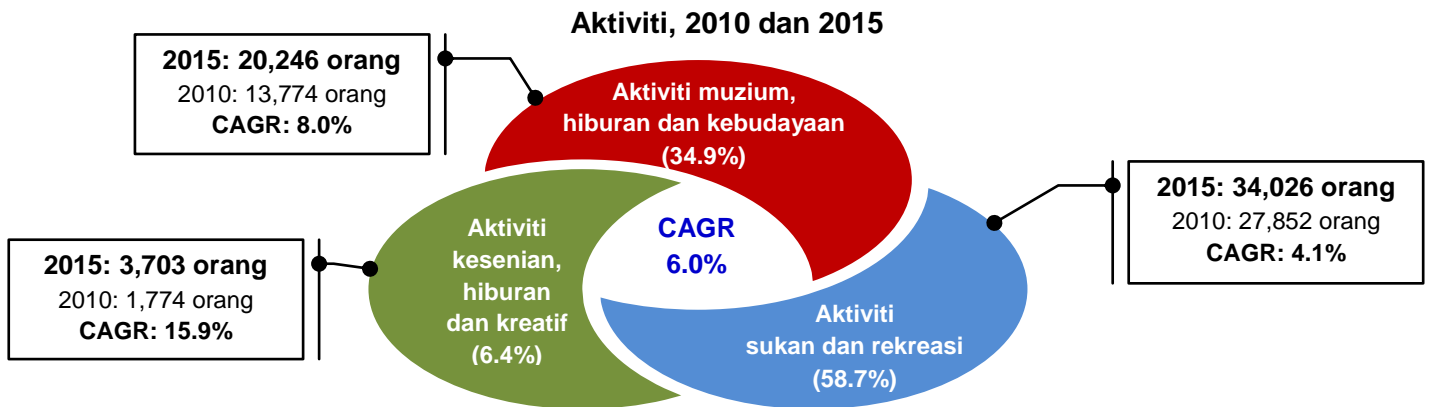


6. BILANGAN PEKERJA

Pada tahun 2015, bilangan pekerja bagi perkhidmatan kesenian, hiburan dan rekreasi adalah seramai 57,975 orang berbanding 43,400 orang pada tahun 2010. Jumlah ini merekodkan pertumbuhan sebanyak 6.0 peratus setahun. Aktiviti sukan dan rekreasi mempunyai bilangan pekerja yang tertinggi iaitu 34,026 orang dengan sumbangan 58.7 peratus, diikuti aktiviti muzium, hiburan dan kebudayaan (20,246 orang; 34.9%) dan aktiviti kesenian, hiburan dan kreatif (3,703 orang; 6.4%) seperti di **Paparan 5**.

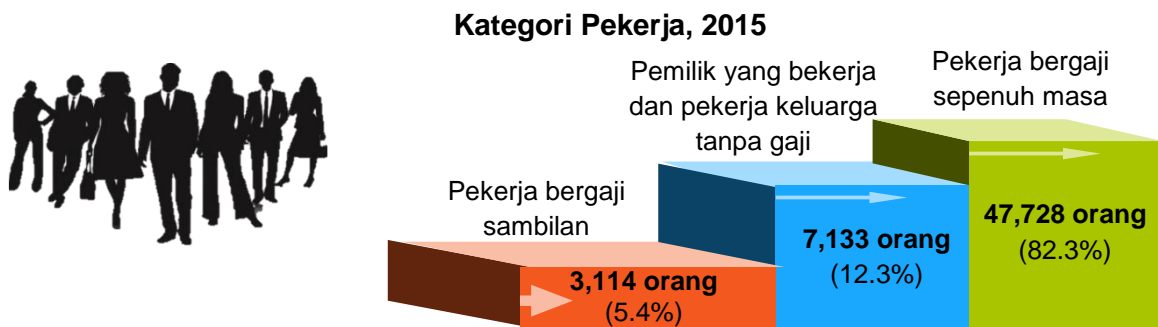

Paparan 5: Bilangan Pekerja Perkhidmatan Kesenian, Hiburan dan Rekreasi mengikut



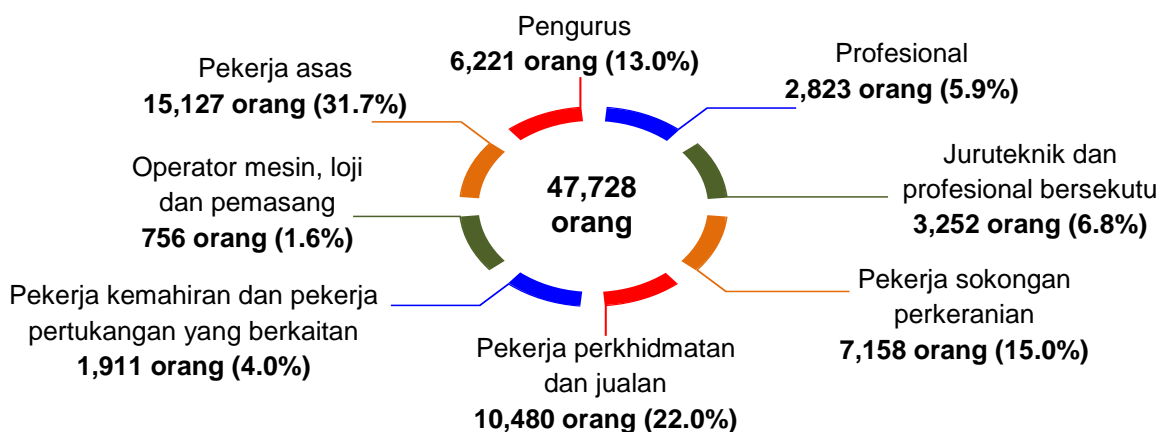
Perkhidmatan kesenian, hiburan dan rekreasi mencatatkan 47,728 orang atau 82.3 peratus pekerja bergaji sepenuh masa dan 7,133 orang (12.3%) pemilik yang bekerja dan pekerja keluarga tanpa gaji. Seramai 3,114 orang (5.4%) direkodkan sebagai pekerja bergaji sambilan seperti di **Paparan 6**.

Bilangan pekerja bergaji sepenuh masa yang tertinggi dicatatkan oleh pekerja asas iaitu 15,127 orang dengan sumbangan 31.7 peratus, diikuti pekerja perkhidmatan dan jualan (10,480 orang; 22.0%) dan pekerja sokongan perkeranian (7,158 orang; 15.0%) seperti ditunjukkan di **Paparan 7**.

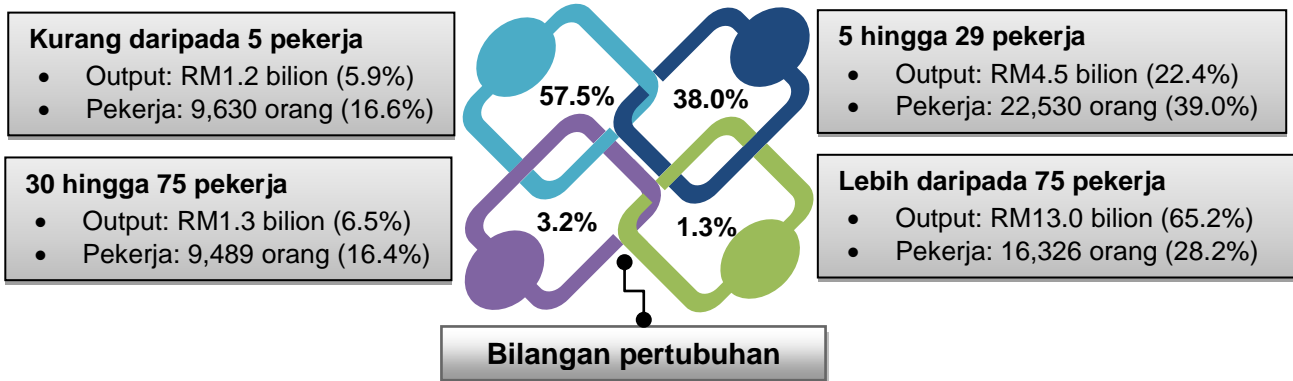

6.1 SAIZ PEKERJA

Pertubuhan dengan saiz pekerja 4 orang dan ke bawah merupakan penyumbang tertinggi bilangan pertubuhan iaitu 3,845 pertubuhan dengan sumbangan 57.5 peratus. Walaupun komposisi bilangan pertubuhan dengan pekerja 4 orang dan ke bawah adalah paling besar, sumbangan kepada nilai output kasar dan pekerja masing-masing adalah hanya 5.9 peratus dan 16.6 peratus seperti yang ditunjukkan dalam **Paparan 8**.

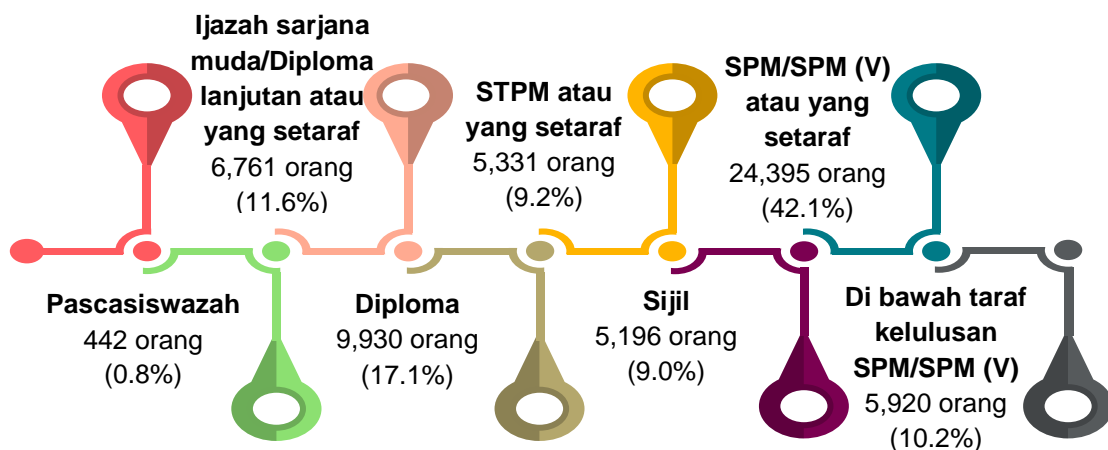
Paparan 8: Saiz Pekerja Perkhidmatan Kesenian, Hiburan dan Rekreasi, 2015



6.2 KELULUSAN PEKERJA

Pekerja dengan kelulusan SPM/SPM (V) atau yang setaraf dan ke bawah adalah majoriti dalam perkhidmatan kesenian, hiburan dan rekreasi iaitu berjumlah 24,395 orang atau 42.1 peratus daripada jumlah pekerja pada tahun 2015. Bilangan kedua tertinggi direkodkan oleh pekerja yang mempunyai kelulusan Diploma, 9,930 orang (17.1%), diikuti oleh pemegang Ijazah Sarjana Muda/Diploma Lanjutan atau yang setaraf iaitu 6,761 orang (11.6%) seperti dipaparkan dalam **Paparan 9**.

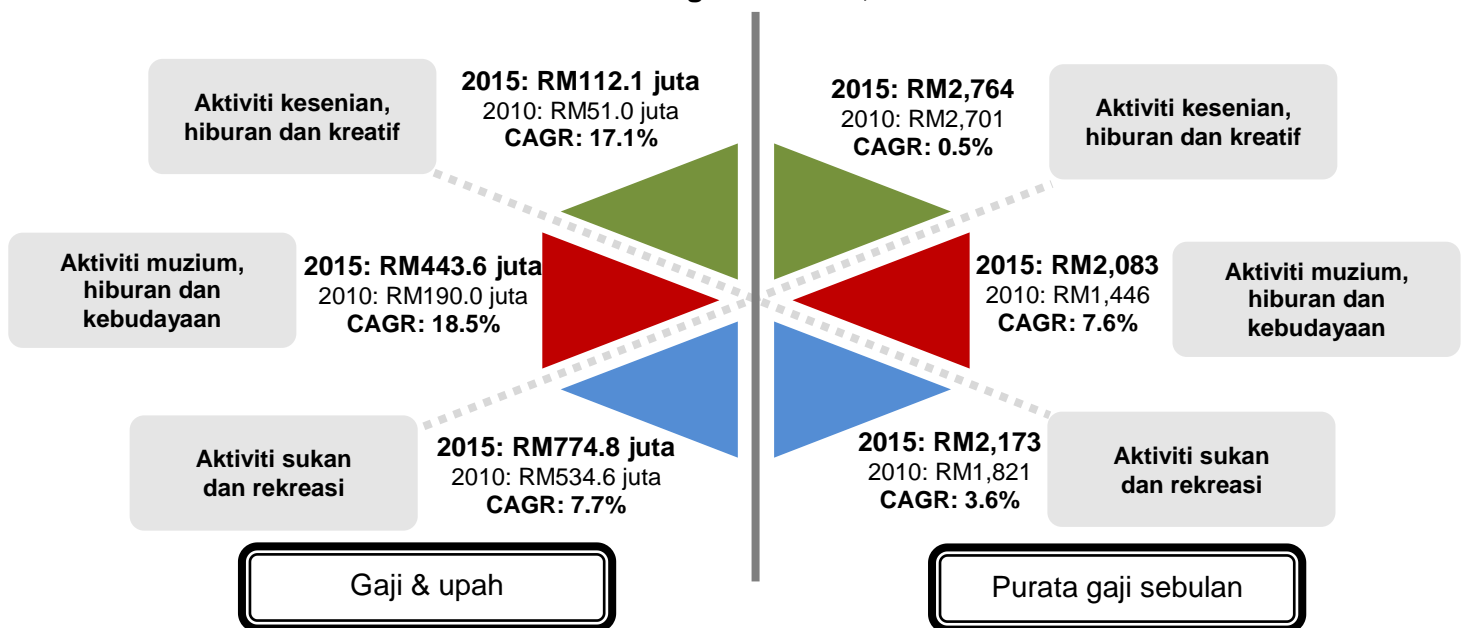
Paparan 9: Bilangan Pekerja Perkhidmatan Kesenian, Hiburan dan Rekreasi mengikut Kelulusan, 2015



7. GAJI & UPAH

Jumlah gaji & upah yang dibayar pada tahun 2015 adalah sebanyak RM1,330.5 juta berbanding RM775.6 juta pada tahun 2010 dengan mencatatkan pertumbuhan 11.4 peratus setahun. Aktiviti sukan dan rekreasi merekodkan jumlah gaji & upah tertinggi iaitu RM774.8 juta dengan sumbangan 58.2 peratus, diikuti oleh aktiviti muzium, hiburan dan kebudayaan (RM443.6 juta; 33.4%) dan aktiviti kesenian, hiburan dan kreatif (RM112.1 juta; 8.4%). Perkhidmatan kesenian, hiburan dan rekreasi mencatatkan purata gaji bulanan sebanyak RM2,181 iaitu meningkat 4.5 peratus berbanding tahun 2010 (RM1,748). Aktiviti kesenian, hiburan dan kreatif merekodkan purata gaji bulanan tertinggi dengan RM2,764, diikuti aktiviti sukan dan rekreasi (RM2,173) dan aktiviti muzium, hiburan dan kebudayaan (RM2,083) seperti di **Paparan 10**.

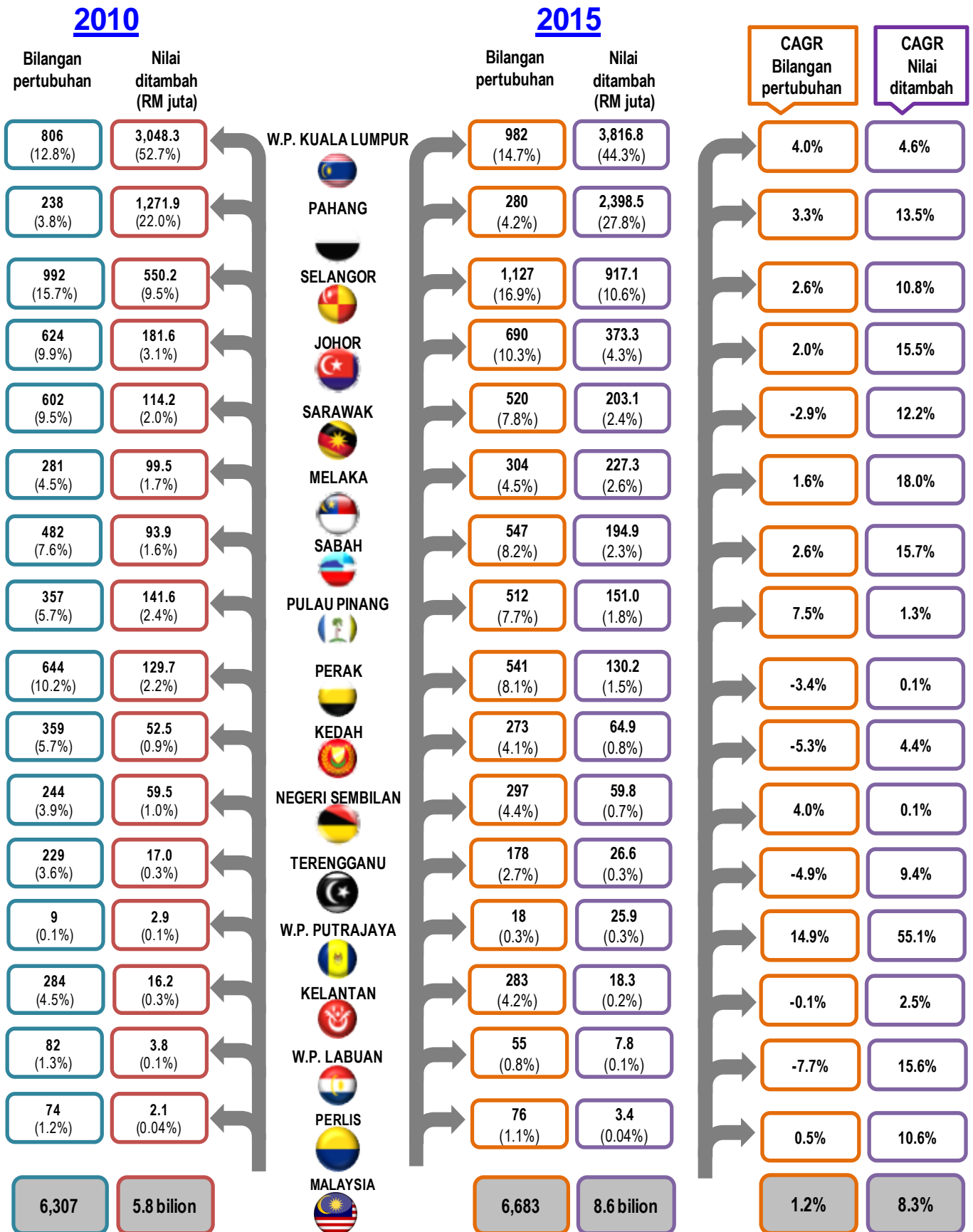

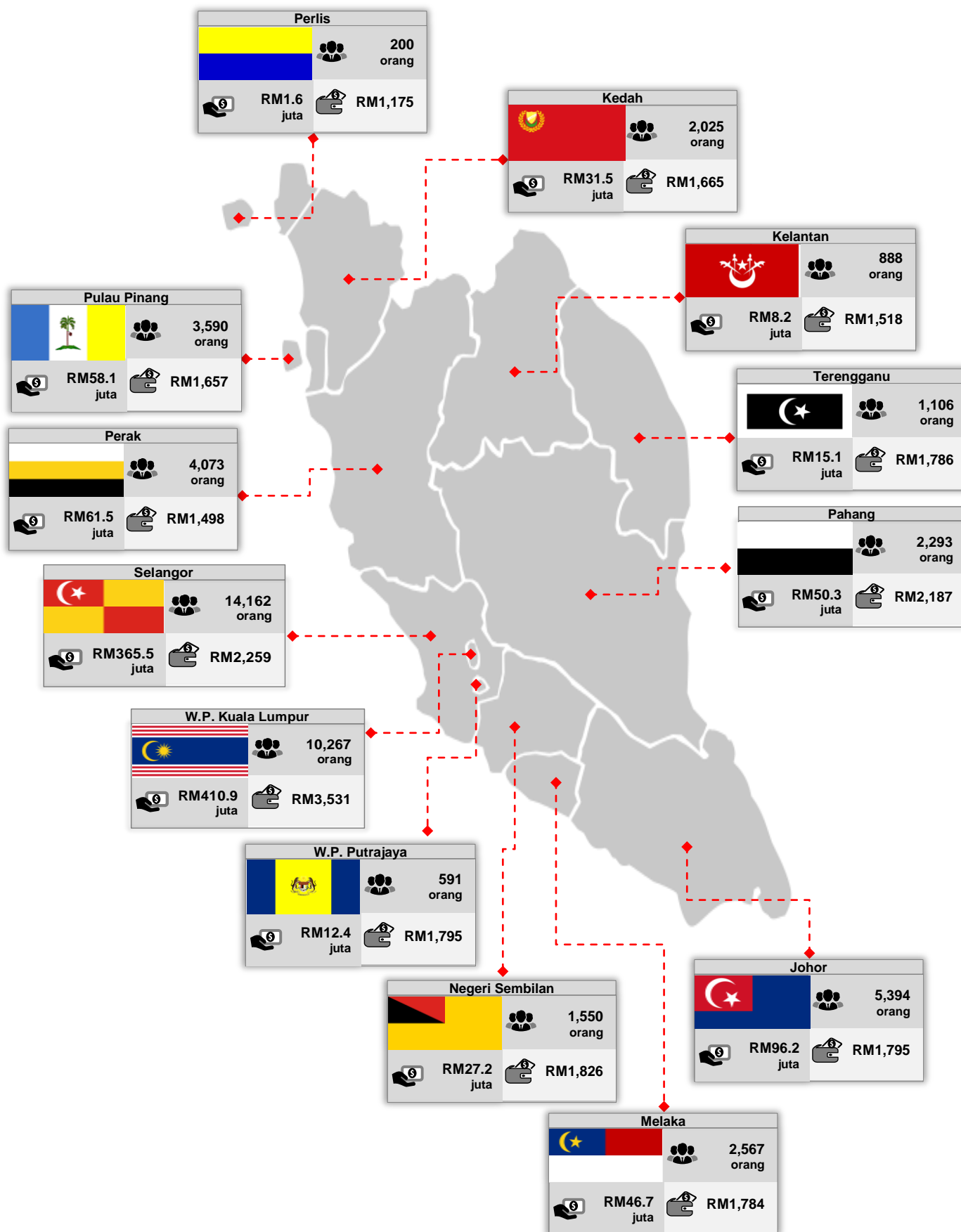
8. PRESTASI MENGIKUT NEGERI

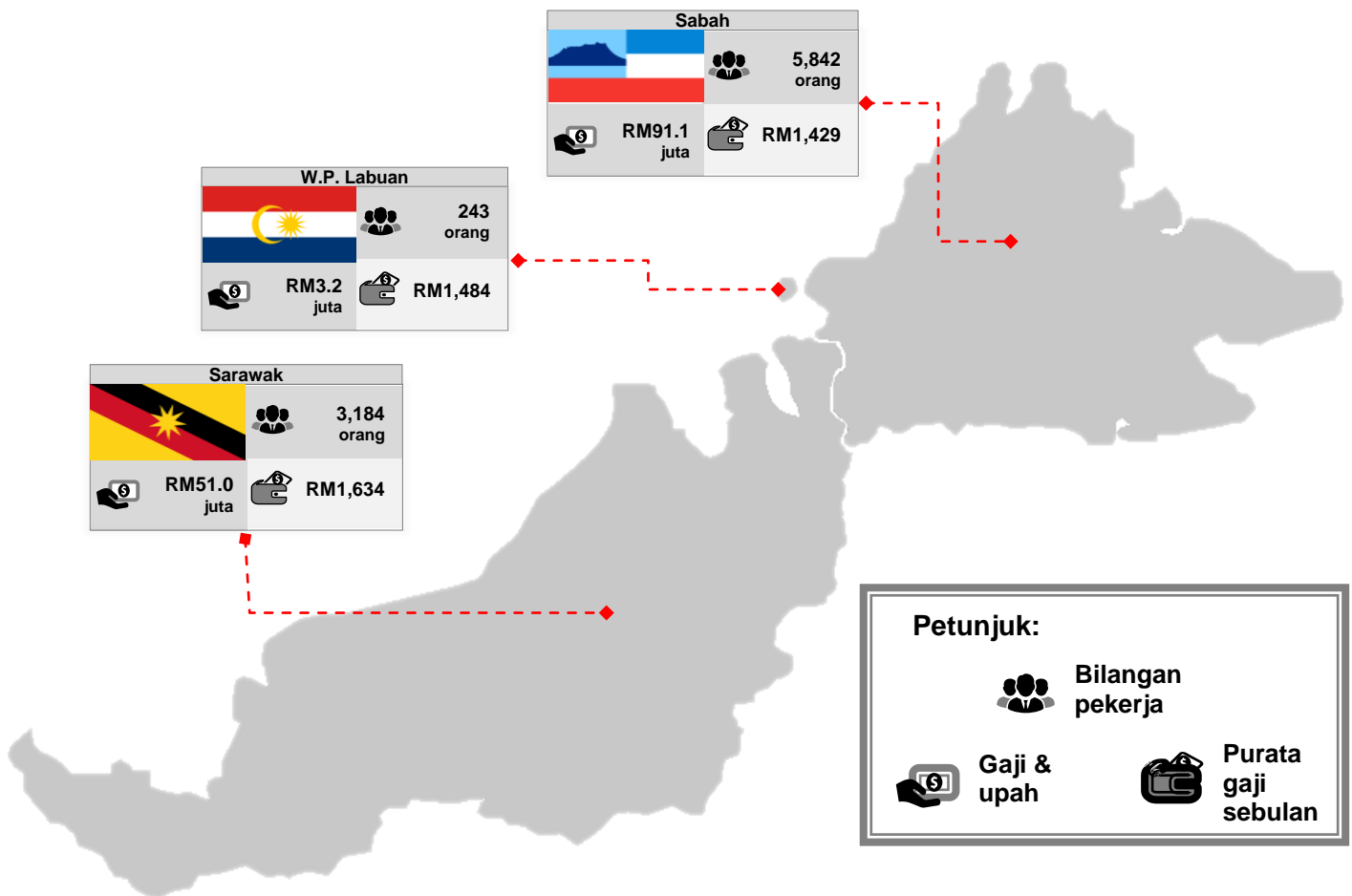
Bilangan pertubuhan tertinggi pada tahun 2015 dicatatkan oleh Selangor iaitu 1,127 pertubuhan dengan sumbangan 16.9 peratus, diikuti W.P. Kuala Lumpur (982 pertubuhan; 14.7%) dan Johor (690 pertubuhan; 10.3%). Bagi nilai ditambah, W.P. Paparan 12: Perangkaan Utama Perkhidmatan Kesenian, Hiburan dan Rekreasi mengikut Negeri, 2015

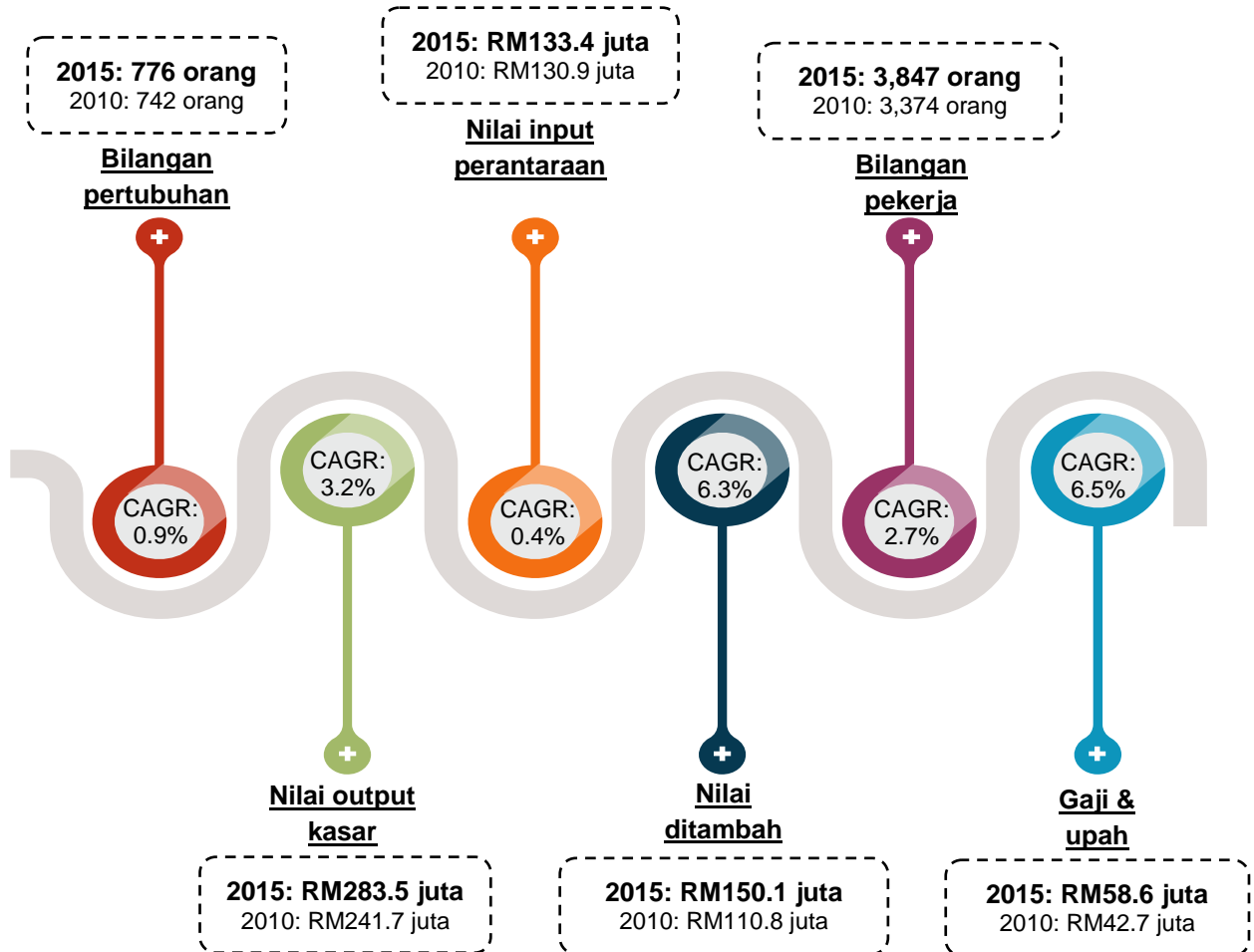




9. PERTUBUHAN MILIKAN WANITA

Pada tahun 2015, terdapat 776 pertubuhan milikan wanita dalam perkhidmatan kesenian, hiburan dan rekreasi berbanding 742 pertubuhan pada tahun 2010. Jumlah ini mencatatkan pertumbuhan sebanyak 0.9 peratus setahun. **Paparan 13** menunjukkan bilangan pertubuhan milikan wanita perkhidmatan kesenian, hiburan dan rekreasi mengikut aktiviti. Bilangan tertinggi pertubuhan milikan wanita dicatatkan oleh aktiviti sukan dan rekreasi iaitu 409 pertubuhan dengan sumbangan 52.7 peratus, diikuti oleh aktiviti muzium, hiburan dan kebudayaan (317 pertubuhan; 40.9%) dan aktiviti kesenian, hiburan dan kreatif (50 pertubuhan; 6.4%).

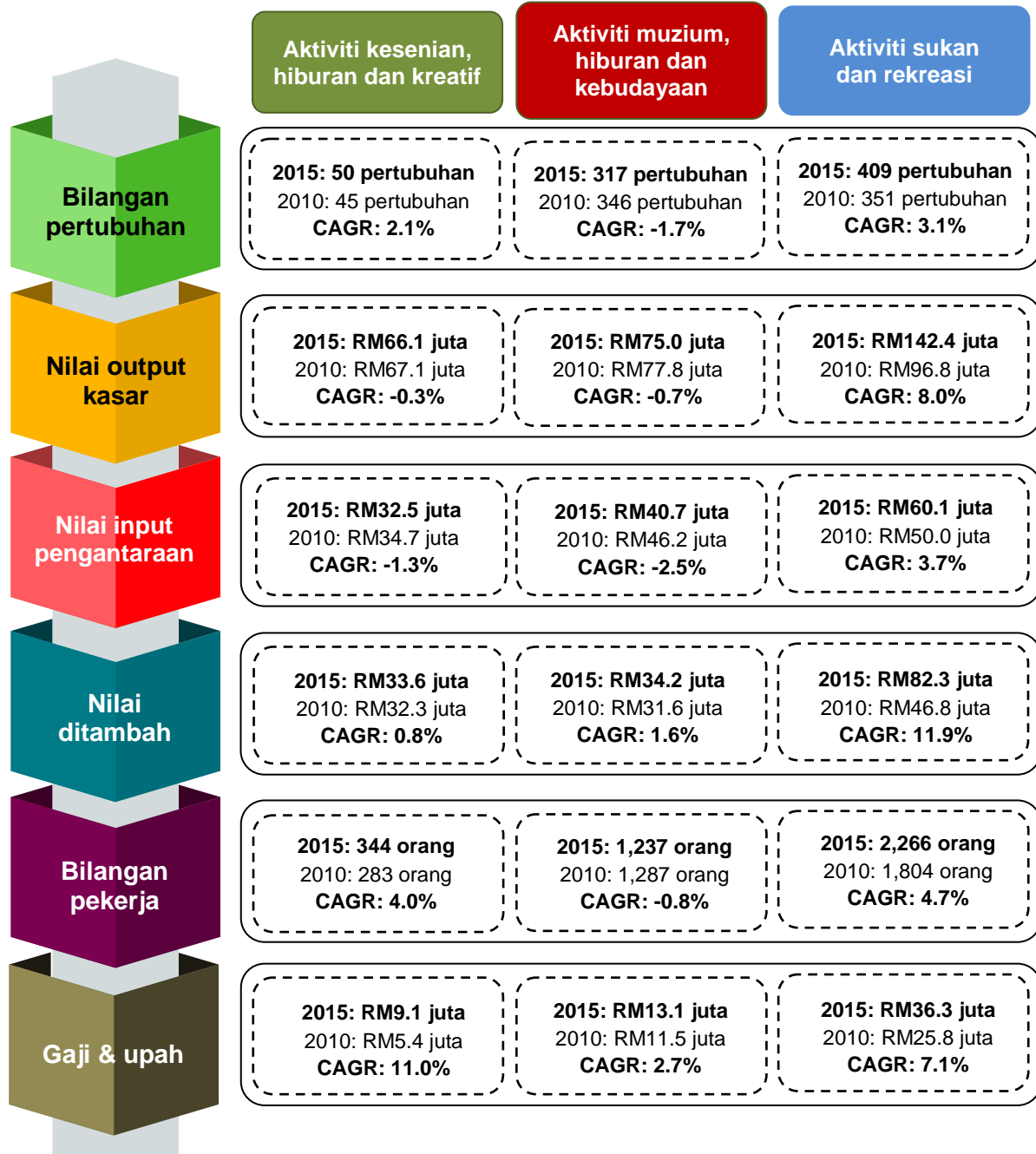

Nilai ditambah yang dihasilkan oleh pertubuhan milikan wanita dalam perkhidmatan kesenian, hiburan dan rekreasi adalah RM150.1 juta pada tahun 2015. Aktiviti sukan dan rekreasi merekodkan nilai ditambah tertinggi iaitu RM82.3 juta dengan sumbangan 54.8 peratus. Ini diikuti aktiviti muzium, hiburan dan kebudayaan (RM34.2 juta; 22.8%) dan aktiviti kesenian, hiburan dan kreatif (RM33.6 juta; 22.4%). Pertubuhan milikan wanita mempunyai 3,847 orang pekerja dengan gaji & upah yang dibayar sebanyak RM58.6 juta seperti di **Paparan 14**.

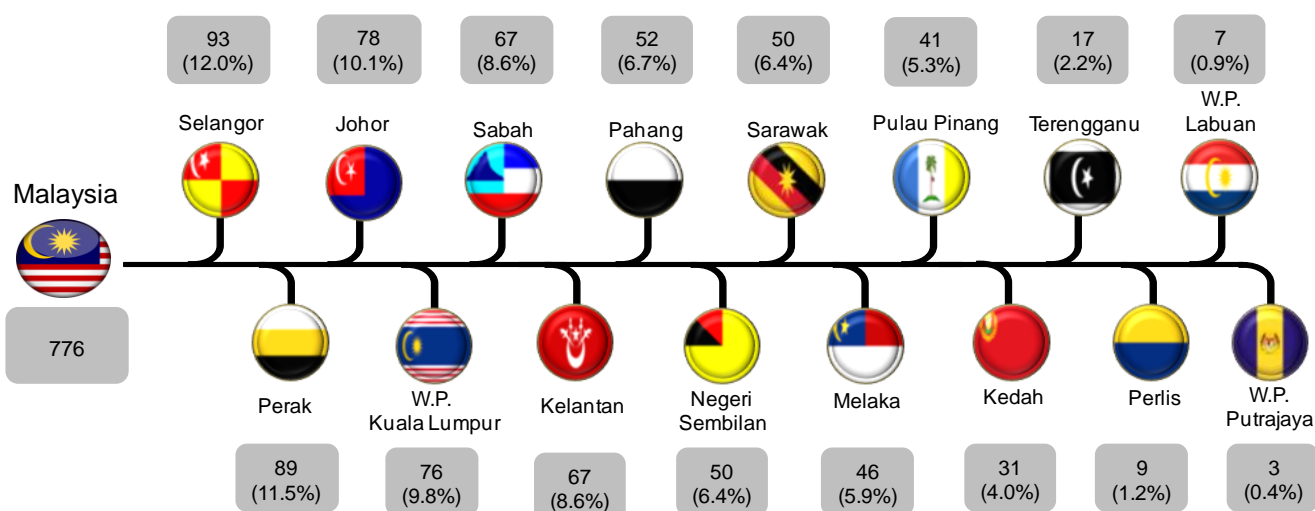

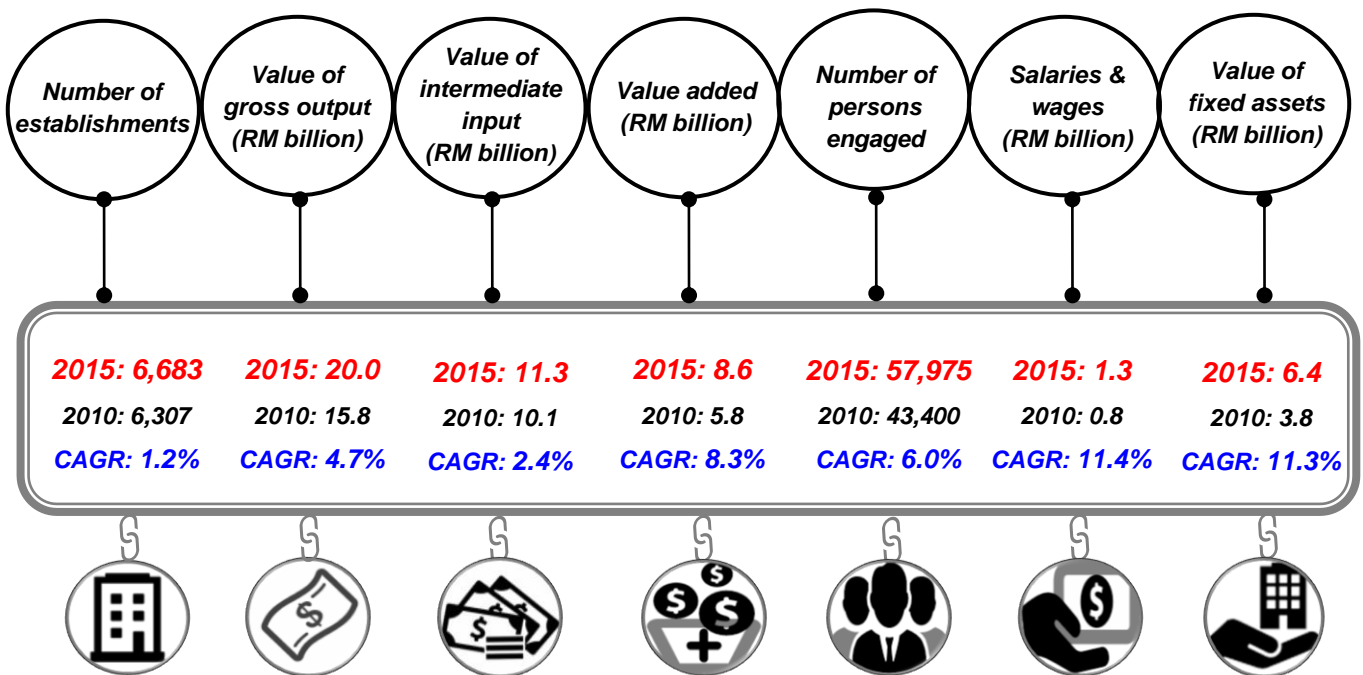
1. INTRODUCTION

This report presents statistics on arts, entertainment and recreation services that was compiled based on Economic Census undertaken in 2016 for reference year 2015. Arts, entertainment and recreation services encompass creative, arts and entertainment activities; museums, amusement and cultural activities and sports and recreation activities.

2. PERFORMANCE OF ARTS, ENTERTAINMENT AND RECREATION SERVICES

Comparison of key statistics of arts, entertainment and recreation services between 2010 and 2015 is provided in **Exhibit 1**. The results of the census showed that there were 6,683 establishments operated in 2015. Total value of gross output generated was RM20.0 billion, while the value added was RM8.6 billion. Number of persons engaged in this services were 57,975 persons with salaries and wages paid amounting to RM1.3 billion. Value of fixed assets for the reference year was RM6.4 billion.

Exhibit 1: Comparison of Key Statistics of Arts, Entertainment and Recreation Services, 2010 and 2015

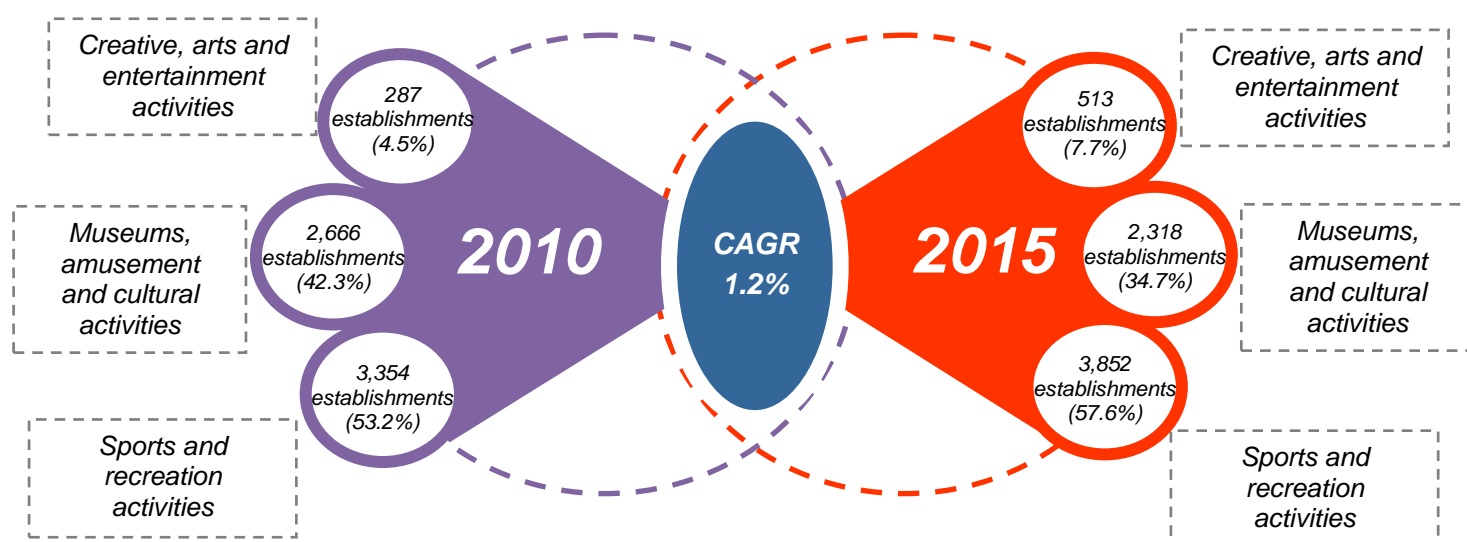

3. NUMBER OF ESTABLISHMENTS

In 2015, a total of 6,683 establishments operated in arts, entertainment and recreation services as compared to 6,307 establishments in 2010. This total registered a compound annual growth rate (CAGR) of 1.2 per cent per annum. Sports and recreation activities recorded the highest number of establishments of 3,852 establishments with 57.6 per cent of share (as illustrated in **Exhibit 2**). This was followed by museums, amusement and cultural activities (2,318 establishments; 34.7%) and creative, arts and entertainment activities (513 establishments; 7.7%).

Exhibit 2: Number of Establishment of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015

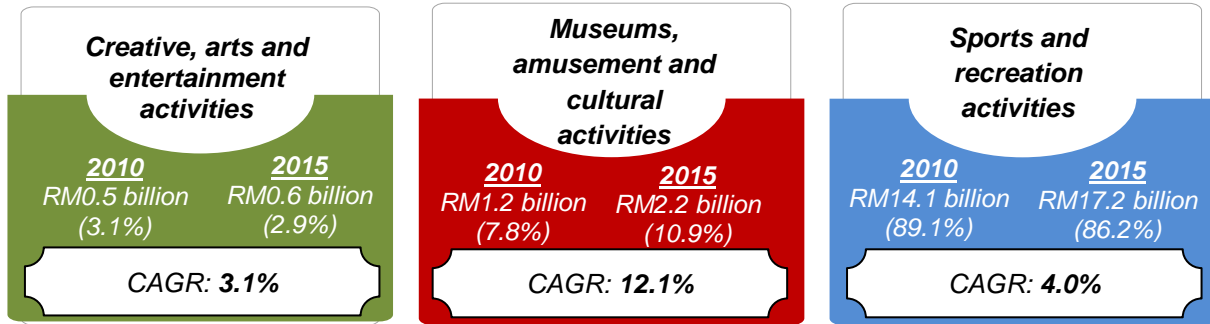


4. VALUE OF GROSS OUTPUT

Value of gross output generated for arts, entertainment and recreation services amounted to RM20.0 billion as compared to RM15.8 billion in 2010. This total registered a CAGR of 4.7 per cent per annum. **Exhibit 3** shows the value of gross output by activities in 2010 and 2015. Sports and recreation activities recorded the highest value of gross output of RM17.2 billion with 86.2 per cent of share, followed by museums, amusement and cultural activities (RM2.2 billion; 10.9%) and creative, arts and entertainment activities (RM0.6 billion; 2.9%).

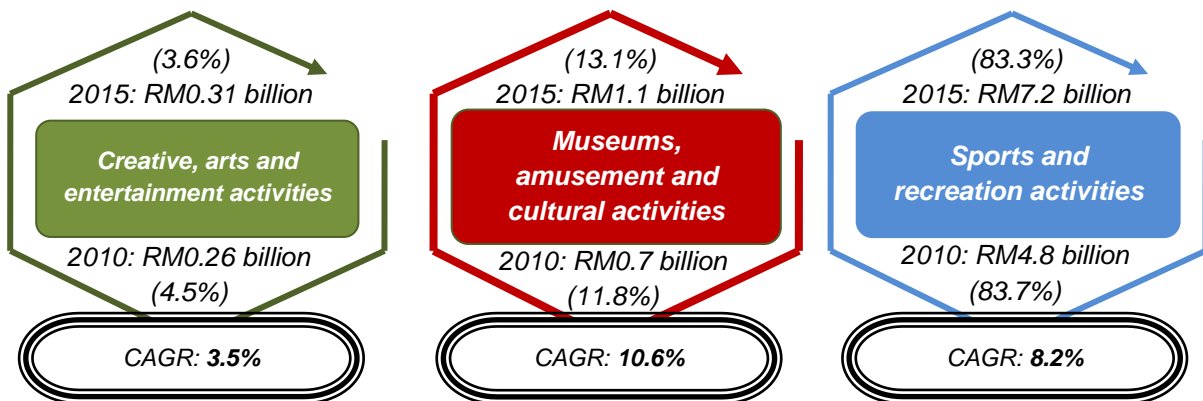
Exhibit 3: Value of Gross Output of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015



5. VALUE ADDED

Value added of arts, entertainment and recreation services posted a growth of 8.3 per cent per annum to RM8.6 billion in 2015 as compared to RM5.8 billion in 2010. In line with the value of gross output, value added of sports and recreation activities recorded the highest of RM7.2 billion with 83.3 per cent of share, followed by museums, amusement and cultural activities (RM1.1 billion; 13.1%) and creative, arts and entertainment activities (RM0.31 billion; 3.6%) as shown in **Exhibit 4**.

Exhibit 4: Value Added of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015

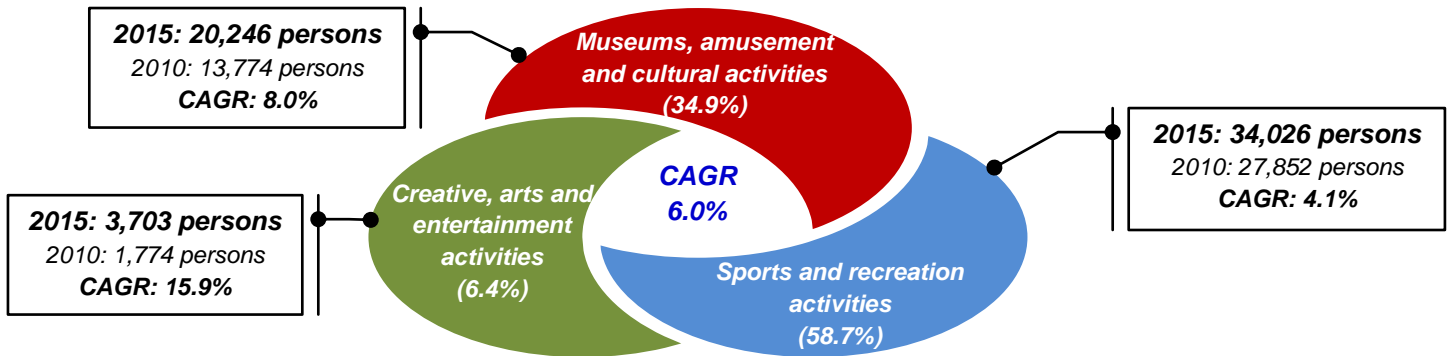


6. NUMBER OF PERSONS ENGAGED

In 2015, number of persons engaged in arts, entertainment and recreation services were 57,975 persons as compared to 43,400 persons in 2010. This total registered a growth of 6.0 per cent per annum. Sports and recreation activities engaged the highest number of workers of 34,026 persons with 58.7 per cent of share, followed by museums, amusement and cultural activities (20,246 persons; 34.9%) and creative, arts and entertainment activities (3,703 persons; 6.4%) as illustrated in **Exhibit 5**.

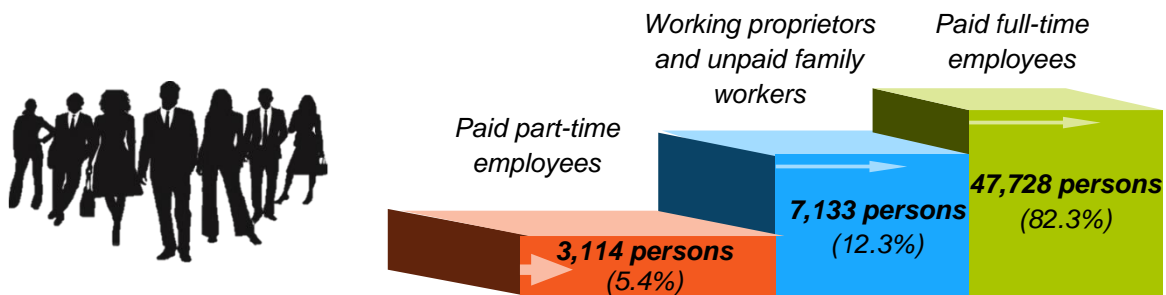

Exhibit 5: Number of Persons Engaged of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015



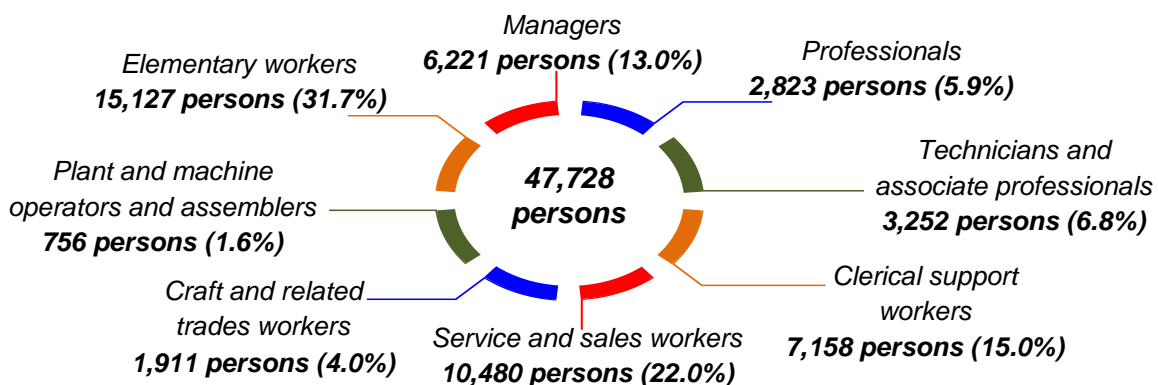
Arts, entertainment and recreation services recorded total of 47,728 persons or 82.3 per cent paid full-time employees and 7,133 persons (12.3%) were working proprietors and unpaid family workers. There were 3,114 persons (5.4%) recorded as paid part-time employees as depicted in **Exhibit 6**.

The highest number of persons engaged in paid full-time employees was contributed by elementary workers amounted to 15,127 persons with 31.7 per cent of share, followed by service and sales workers (10,480 persons; 22.0%) and clerical support workers (7,158 persons; 15.0%) as shown in **Exhibit 7**.

Exhibit 7: Number of Paid Full-Time Employees of Arts, Entertainment and Recreation by Category of Workers, 2015

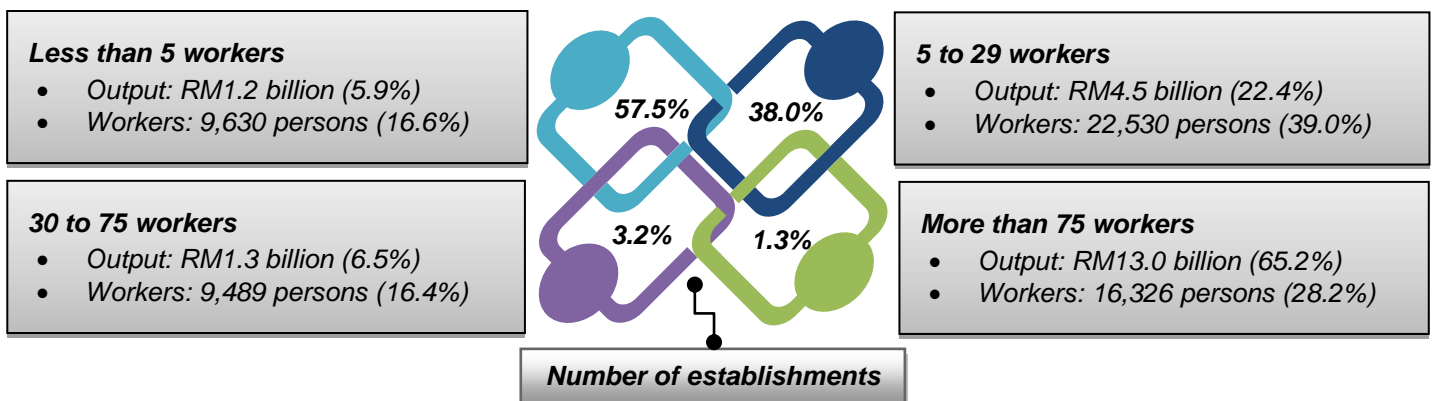

6.1 SIZE OF EMPLOYMENT

Establishments with employment size of 4 persons and below posted the highest number of establishments of 3,845 establishments or 57.5 per cent of share. Although in composition the number of establishments with 4 persons and below were the largest, the contribution to value of gross output and number of persons engaged were only 5.9 per cent and 16.6 per cent respectively as shown in **Exhibit 8**.

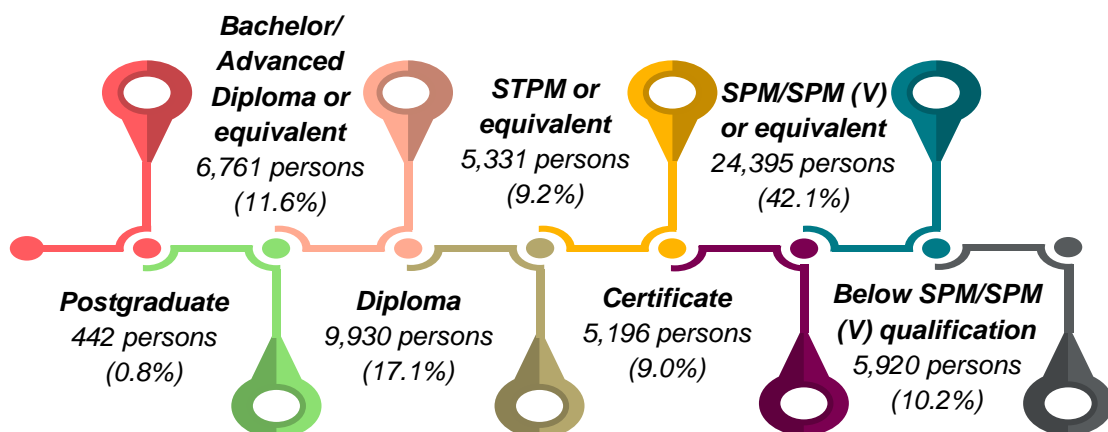
Exhibit 8: Size of Employment of Arts, Entertainment and Recreation, 2015



6.2 QUALIFICATION OF WORKERS

Workers with the qualification of SPM/SPM (V) or equivalent and below were the majority in arts, entertainment and recreation services with 24,395 persons or 42.1 per cent of total persons engaged in 2015. The second highest recorded by workers whom in Diploma holder, 9,930 persons (17.1%), followed by Bachelor/Advanced Diploma or equivalent holder with 6,761 persons (11.6%) as depicted in **Exhibit 9**.

Exhibit 9: Number of Persons Engaged of Arts, Entertainment and Recreation by Qualifications, 2015

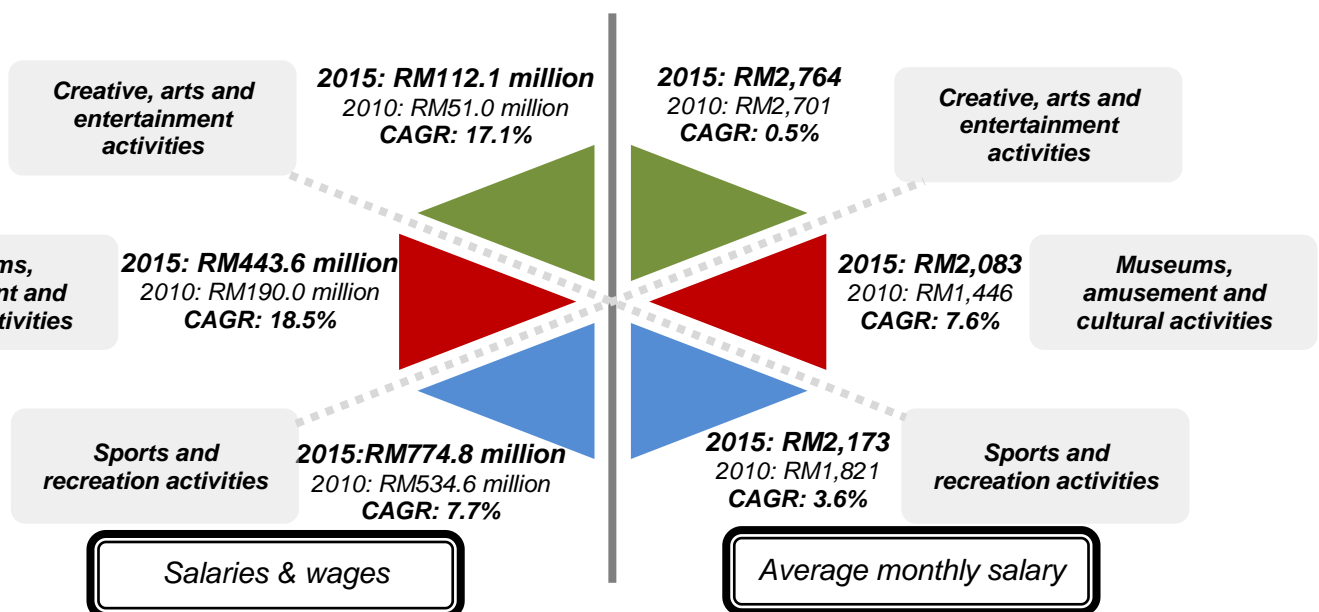

7. SALARIES & WAGES

Total salaries & wages paid in 2015 was RM1,330.5 million as compared to RM775.6 million in 2010 which posted a growth of 11.4 per cent per annum. Sports and recreation activities recorded the highest salaries & wages paid of RM774.8 million with 58.2 per cent of share, followed by museums, amusement and cultural activities (RM443.6 million; 33.4%) and creative, arts and entertainment activities (RM112.1 million; 8.4%). Arts, entertainment and recreation services recorded an average of monthly salary of RM2,181 increased 4.5 per cent as compared to 2010 (RM1,748). Creative, arts and entertainment activities recorded the highest average monthly salary with RM2,764, followed by sports and recreation activities (RM2,173) and museums, amusement and cultural activities (RM2,083) as shown in **Exhibit 10**.

Exhibit 10: Salaries & Wages and Average Monthly Salary of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015

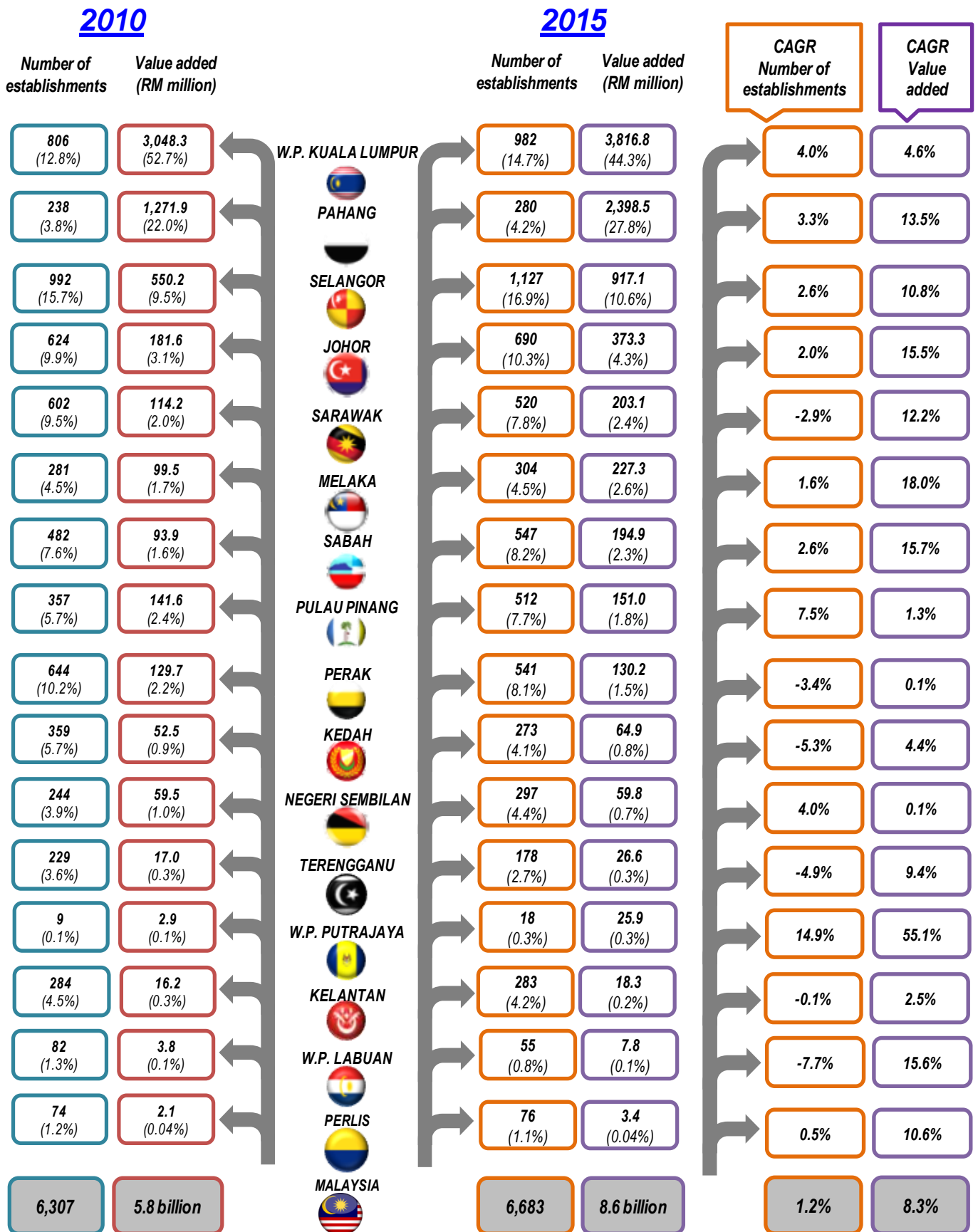


8. PERFORMANCE BY STATE

The highest number of establishments in 2015 were registered by Selangor of 1,127 establishments with 16.9 per cent of share, followed by W.P. Kuala Lumpur (982 establishments; 14.7%) and Johor (690 establishments; 10.3%). In term of value added, W.P. Kuala Lumpur recorded the highest value of RM3.8 billion with the share of 44.3 per cent, followed by Pahang (RM2.4 billion; 27.8%) and Selangor (RM0.9 billion; 10.6%). **Exhibit 11** shows the number of establishments and value added of arts, entertainment and recreation services by states while **Exhibit 12** shows the others key statistics by states.

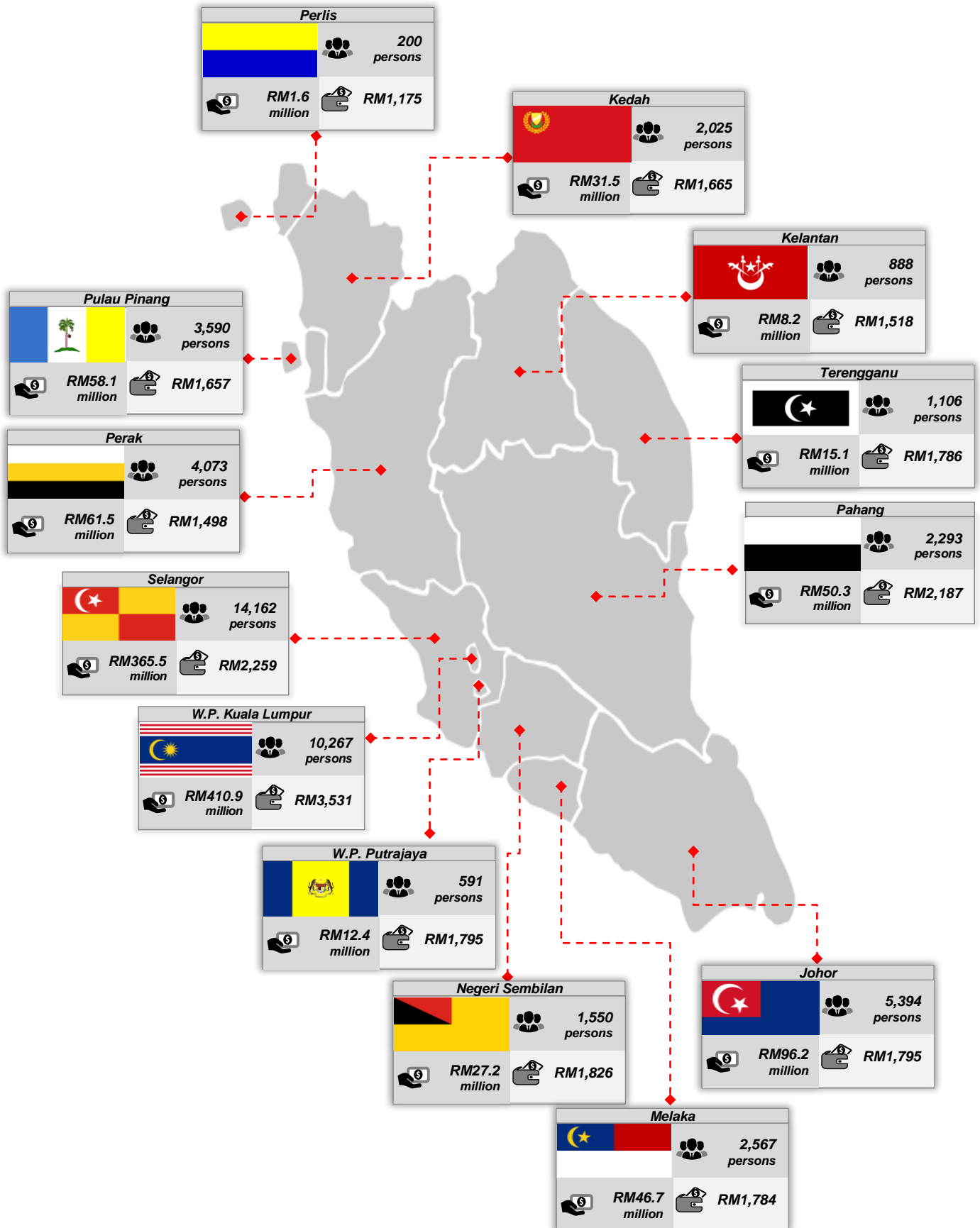

Exhibit 11: Number of Establishments and Value Added of Arts, Entertainment and Recreation by States, 2010 dan 2015

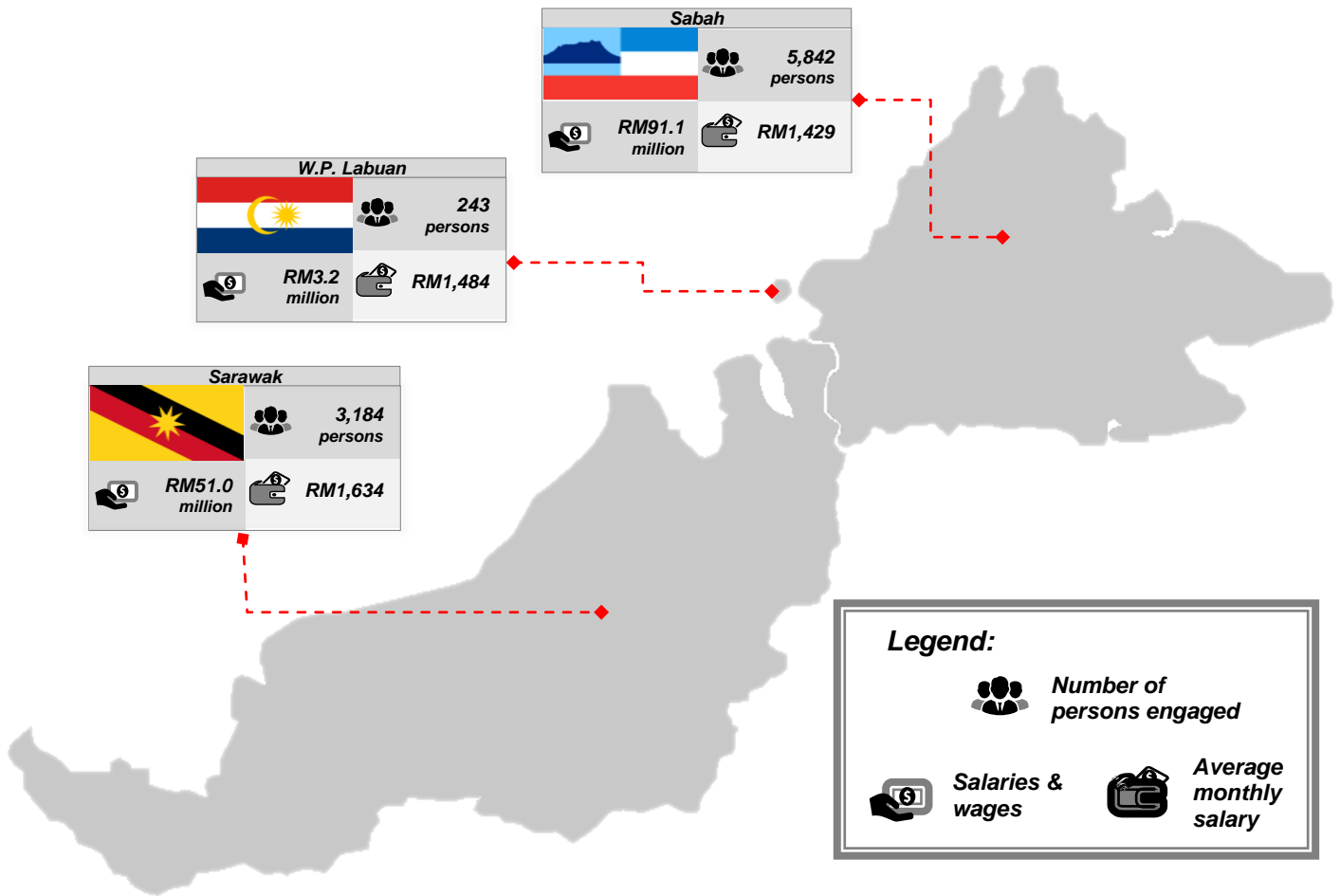

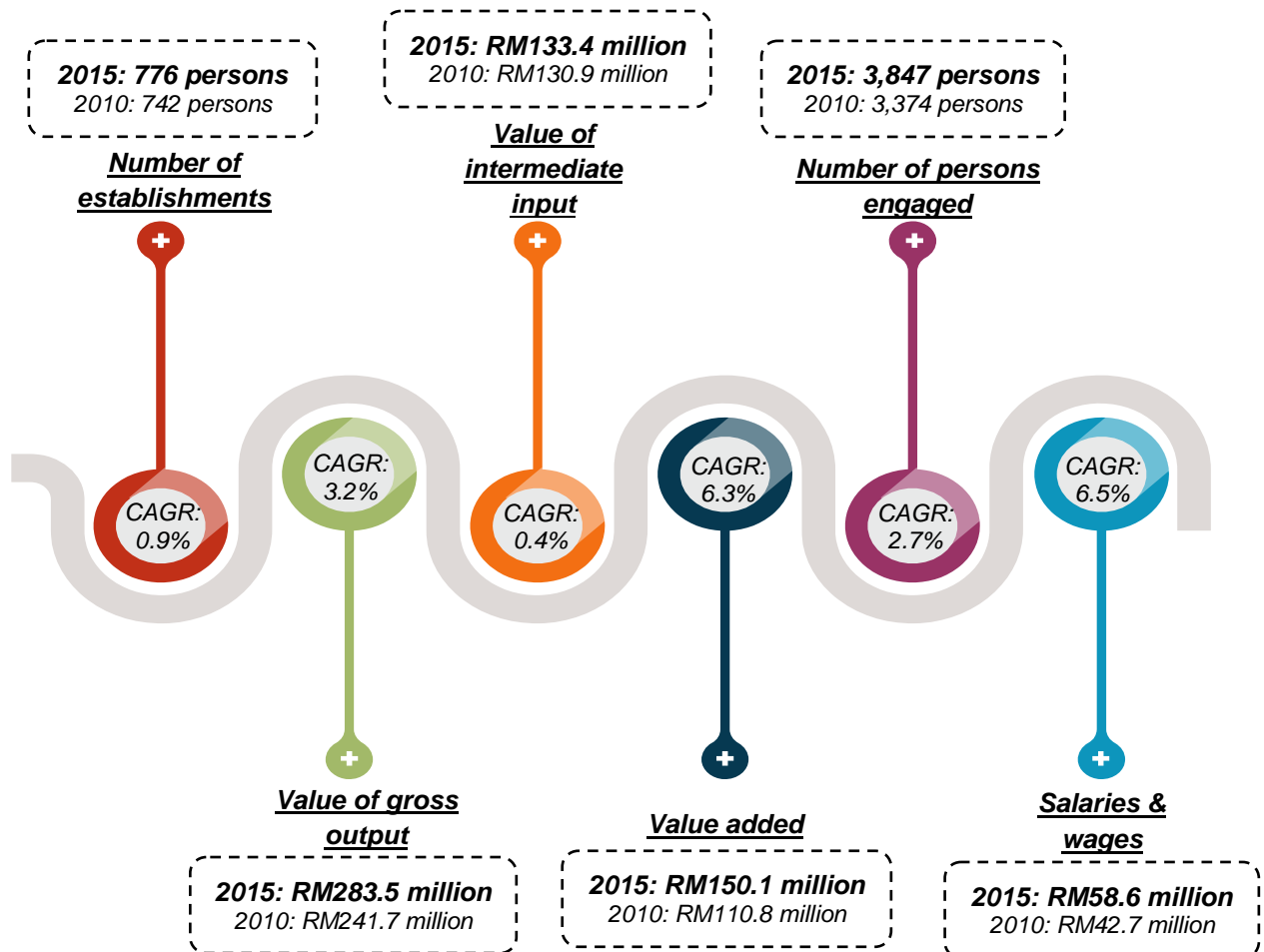


9. WOMEN-OWNED ESTABLISHMENTS

In 2015, there were 776 women-owned establishments in arts, entertainment and recreation services as compared to 742 establishments in 2010. This total registered a growth of 0.9 per cent per annum. **Exhibit 13** shows the number of women-owned establishments of arts, entertainment and recreation services by activities. The highest number of women-owned establishments were recorded in sports and recreation activities with 409 establishments with 52.7 per cent of share, followed by museums, amusement and cultural activities (317 establishments; 40.9%) and creative, arts and entertainment activities (50 establishments; 6.4%).

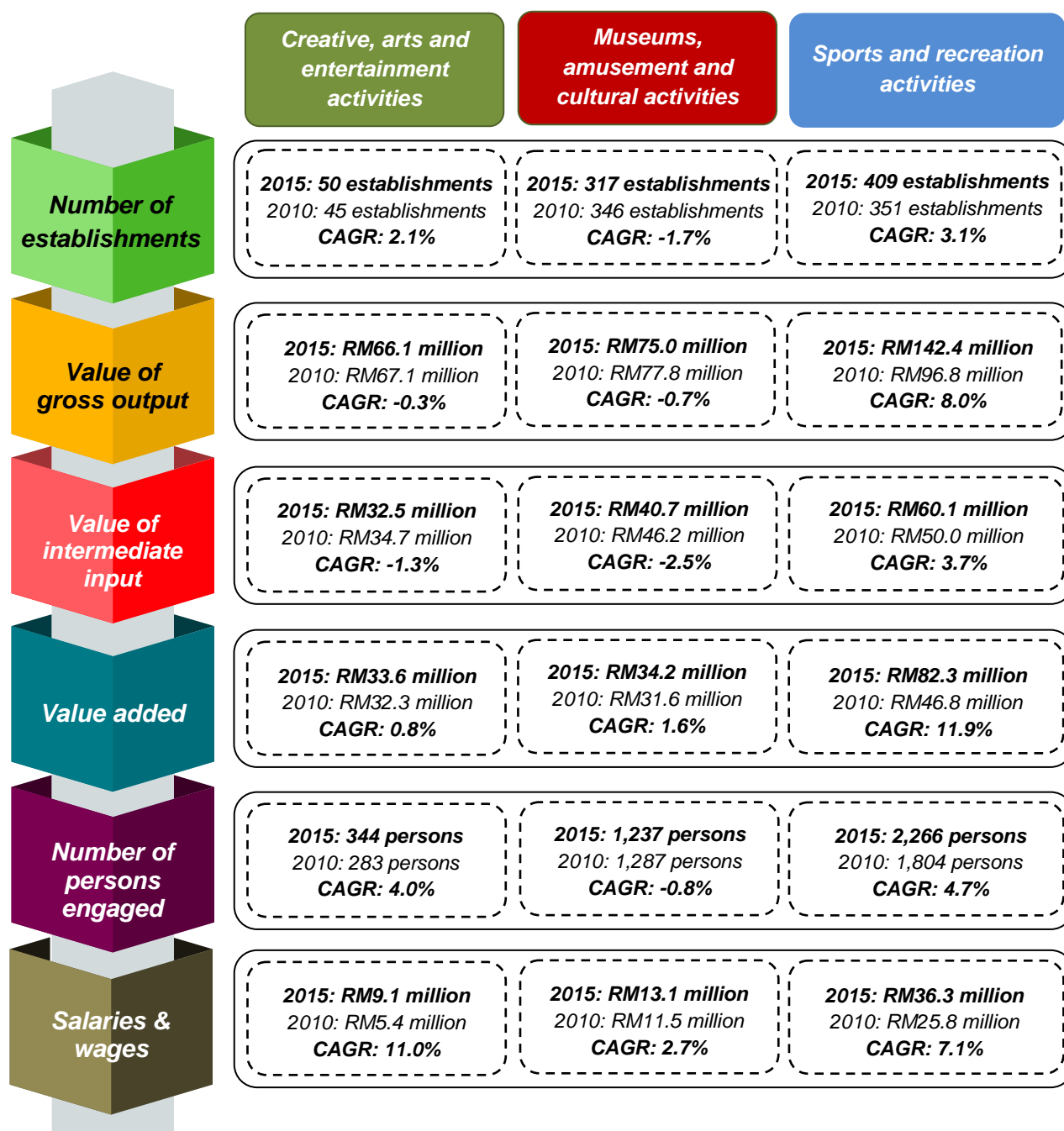
Exhibit 13: Key Statistics of Women-Owned Establishments of Arts, Entertainment and Recreation Services, 2010 and 2015



Value added generated by women-owned establishments in arts, entertainment and recreation services was RM150.1 million in 2015. Sports and recreation activities recorded the highest value added of RM82.3 million with 54.8 per cent of share. This was followed by museums, amusement and cultural activities (RM34.2 million; 22.8%) and creative, arts and entertainment activities (RM33.6 million; 22.4%). Women-owned establishments engaged a total of 3,847 workers with salaries & wages disbursed amounted to RM58.6 million as illustrated in **Exhibit 14**.

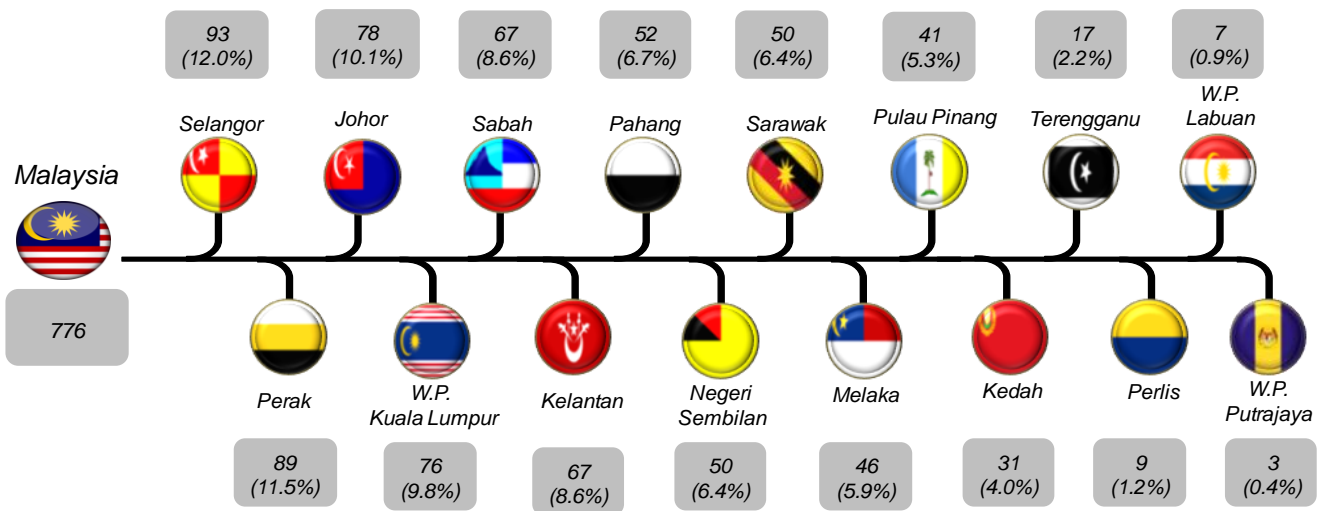
Exhibit 14: Key Statistics of Women-Owned Establishments of Arts, Entertainment and Recreation Services by Activities, 2010 and 2015

1. Skop dan liputan

Banci ini meliputi pertubuhan berdaftar yang terlibat dalam **perkhidmatan kesenian, hiburan dan rekreasi** yang merangkumi aktiviti utama berikut:

- i. Aktiviti kesenian, hiburan dan kreatif;
- ii. Aktiviti muzium, hiburan dan kebudayaan; dan
- iii. Aktiviti sukan dan rekreasi.

Keseluruhannya, liputan banci bagi perkhidmatan kesenian, hiburan dan rekreasi terdiri daripada 38 industri di peringkat 5-digit mengikut Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 Ver. 1.0. Senarai lengkap industri seperti di **Lampiran**.

2. Sumber rangka

Sumber utama rangka pertubuhan diperoleh daripada agensi seperti Suruhanjaya Syarikat Malaysia (SSM), Pihak Berkuasa Tempatan (PBT), Jabatan Pendaftaran Pertubuhan Malaysia (ROS), Suruhanjaya Koperasi Malaysia (SKM), Kementerian Belia dan Sukan dan sumber-sumber lain.

Rangka dikemaskini setiap tahun untuk mengambil kira pertubuhan baru dan sebarang perubahan dalam status pertubuhan seperti tutup, tidak beroperasi, perubahan jenis aktiviti atau alamat untuk memastikan maklumat yang terdapat di dalam rangka adalah yang paling terkini.

3. Jenis aktiviti perniagaan

Jenis aktiviti perniagaan merujuk kepada aktiviti utama dan sekunder. Aktiviti utama merujuk kepada aktiviti yang mana pertubuhan menggunakan sebahagian besar daripada sumbernya atau yang memberikan sumbangan besar dari segi pendapatan. Aktiviti sekunder didefinisikan sebagai aktiviti sampingan kepada aktiviti utama. Klasifikasi industri bagi pertubuhan adalah mengikut aktiviti utamanya berdasarkan kepada **Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 Ver.1.0**. MSIC 2008 Ver.1.0 adalah selaras dengan Piawaian Klasifikasi Industri Antarabangsa bagi Semua Aktiviti Ekonomi (ISIC), Semakan Ke-4, Pertubuhan Bangsa-Bangsa Bersatu, dengan pengubahsuaian untuk keperluan tempatan.

4. Konsep dan definisi

Definisi perkhidmatan kesenian, hiburan dan rekreasi yang diguna pakai dalam penerbitan ini berasaskan kepada MSIC 2008 Ver. 1.0:

Perkhidmatan kesenian, hiburan dan rekreasi termasuk pelbagai aktiviti bagi memenuhi minat orang awam dalam aktiviti kebudayaan, hiburan dan rekreasi meliputi persembahan secara langsung, operasi muzium, perjudian, sukan dan aktiviti rekreasi.

i. Aktiviti kesenian, hiburan dan kreatif

Aktiviti ini termasuk operasi kemudahan dan penyediaan perkhidmatan untuk memenuhi keperluan kebudayaan dan hiburan pelanggan. Ini termasuk produksi dan promosi, serta penglibatan dalam persembahan secara langsung termasuk produksi persembahan teater secara langsung, konsert dan opera, pameran atau pertunjukan untuk tontonan umum, penyediaan kemahiran artistik, kreatif seperti aktiviti pemahat, pelukis, kartunis dan lain-lain, aktiviti penulis berseorangan, termasuk juga aktiviti jurnalis bebas dan kerja pemeliharaan dan penyimpanan karya seni. Kumpulan ini termasuk juga aktiviti penerbit atau pengusaha acara persembahan seni secara langsung dengan atau tanpa kemudahan.

ii. Aktiviti muzium, hiburan dan kebudayaan

Aktiviti ini termasuk operasi semua jenis muzium, taman botani, zoologi, termasuk juga aktiviti taman rekreasi dan pantai serta aktiviti kafe siber/pusat internet.

iii. Aktiviti sukan dan rekreasi

Aktiviti ini termasuk operasi kemudahan sukan; aktiviti sukan berkumpul atau kelab terutamanya yang mengambil bahagian dalam acara sukan secara langsung, ahli sukan bebas yang terlibat dalam acara sukan atau perlumbaan secara langsung. Aktiviti ini juga termasuk jurulatih sukan yang menyediakan khidmat khusus untuk menyokong

peserta dalam acara atau pertandingan sukan, pengusaha arena dan stadium, aktiviti lain bagi penganjuran, promosi atau mengurus sukan dan lain-lain aktiviti sukan. Perjudian dan pertaruhan seperti penjualan tiket loteri, operasi kasino dan mesin perjudian juga termasuk dalam aktiviti ini.

5. Unit melapor

Bilangan pertubuhan yang dilaporkan dalam penerbitan ini berbeza dengan data awalan yang dikeluarkan dalam penerbitan Banci Ekonomi 2016 Statistik Pertubuhan. Perbezaan ini disebabkan oleh analisis terkini status cawangan, pengelasan industri dan status operasi pertubuhan.

Unit melapor bagi banci ini ialah **pertubuhan**. Sesebuah pertubuhan secara ideal ditakrifkan sebagai “satu unit ekonomi yang bergiat di bawah satu hak milik atau penguasaan tunggal, iaitu di bawah satu entiti yang sah. Ia menjalankan satu jenis subsektor ekonomi utama di satu tempat/lokasi fizikal”. Setiap pertubuhan diberikan klasifikasi industri berdasarkan aktiviti utamanya dan bukannya mengikut aktiviti syarikat induk.

Setiap cawangan daripada organisasi yang mempunyai beberapa cawangan di lokasi yang berbeza dari segi konsep dianggap sebagai pertubuhan yang berlainan. Pertubuhan berkenaan diminta memberikan penyata yang berasingan bagi setiap kegiatannya dari segi nilai. Walau bagaimanapun, dari segi praktis akaun biasanya disediakan secara berpusat kerana kesukaran untuk memperoleh data yang berasingan bagi setiap unit atau cawangan. Entiti atau ‘*enterprise*’ ini akan dianggap sebagai satu unit pelapor dan dibenarkan mengemukakan soal selidik yang menggabungkan semua unit atau cawangannya.

6. Nilai output kasar

Nilai output kasar ditakrifkan dengan memasukkan perkara berikut:

- Pendapatan daripada perkhidmatan yang disediakan
- + Pendapatan daripada jualan tiket/bayaran masuk
- + Pendapatan daripada yuran keahlian
- + Pendapatan daripada aktiviti rekreasi
- + Pendapatan daripada aktiviti perjudian dan pertaruhan

- + Pendapatan sewa yang diterima kecuali tanah
- + Pendapatan daripada perkhidmatan pengurusan

- + Pendapatan operasi lain
- + Nilai jualan barangan yang dibeli untuk dijual semula
- Nilai barang yang dibeli untuk dijual semula dalam keadaan sama seperti dibeli
- Bayaran hadiah kemenangan/rebat

7. Nilai input perantaraan

Bermula tahun 2012, perbelanjaan penyelidikan dan pembangunan telah dikeluarkan daripada pengiraan input perantaraan dan diambilkira sebagai perbelanjaan harta selaras dengan penggunaan *Recommendation of System of National Accounts (SNA) 2008*. Nilai input perantaraan ditakrifkan dengan memasukkan perkara berikut:

- Perbelanjaan cari gali bahan-bahan muzium/sejarah
- + Perbelanjaan pemuliharaan bahan-bahan muzium/sejarah
- + Kos pameran dan paparan
- + Pembelian bahan makanan haiwan
- + Bayaran pembaikan dan penyelenggaraan
- + Perbelanjaan alat tulis, bekalan pejabat dan bekalan lain
- + Pembelian perkhidmatan pengangkutan
- + Perbelanjaan perjalanan dan hiburan
- + Perbelanjaan elektrik, air, pembakar, pelincir dan gas
- + Bayaran perakaunan, kesetiausahaan dan audit
- + Bayaran guaman dan perkhidmatan profesional lain
- + Bayaran pengurusan
- + Komisen dan bayaran agensi
- + Bayaran telekomunikasi, pos dan percetakan

- + Pengiklanan, pemasaran dan promosi
- + Premium insurans kecuali insurans pampasan kerja
- + Bayaran bagi perkhidmatan keselamatan
- + Bayaran sewa tidak termasuk sewa penggunaan tanah
- + Perbelanjaan operasi lain
- + Stok awal
- Stok akhir

8. Nilai ditambah

Nilai ditambah adalah tambahan kepada nilai barangan dan perkhidmatan yang dikeluarkan oleh sesebuah pertubuhan. Nilai ditambah diperoleh daripada perbezaan antara nilai output kasar dengan nilai input perantaraan.

9. Bilangan pekerja

Bilangan pekerja meliputi semua orang yang diambil bekerja pada bulan Disember atau pada tempoh pembayaran gaji terakhir pada tahun rujukan. Bilangan orang yang bekerja dikategorikan seperti berikut:

i. Pemilik yang bekerja dan rakan niaga yang aktif

Kategori ini merujuk kepada semua pemilik perseorangan dan rakan niaga, sambilan atau sepenuh masa, yang bekerja dengan aktif dalam pertubuhan. Justeru itu, ia tidak termasuk rakan niaga yang tidak aktif.

ii. Pekerja keluarga tanpa gaji

Kategori ini meliputi semua ahli isi rumah pemilik pertubuhan yang melaksanakan kerja tertentu (sepenuh masa atau sambilan) dan bekerja sekurang-kurangnya satu pertiga daripada waktu bekerja biasa yang diamalkan oleh pertubuhan berkenaan tanpa mendapat bayaran secara 'regular' sama ada dalam bentuk wang tunai atau mata benda bagi kerja yang dilakukan. Biasanya pekerja berkenaan mendapat makanan, tempat tinggal dan bantuan lain sebagai sebahagian daripada ahli isi rumah pemilik dan terus mendapatnya sama ada mereka bekerja atau tidak di pertubuhan tersebut.

iii. Pekerja bergaji sepenuh masa

Ia merujuk kepada semua pekerja bergaji yang bekerja sekurang-kurangnya 6 jam sehari dan sekurang-kurangnya 20 hari sebulan.

iv. Pekerja bergaji sambilan

Ia merujuk kepada semua pekerja bergaji yang bekerja kurang daripada 6 jam sehari dan/atau kurang daripada 20 hari sebulan.

10. Kategori kemahiran

Kategori kemahiran telah dikelaskan berdasarkan Piawaian Pengkelasan Pekerjaan Malaysia (MASCO) 2013 adalah seperti berikut:

i. Pekerja mahir

Pengurusan, profesional, penyelidik serta juruteknik dan profesional bersekutu.

ii. Pekerja separuh mahir

Pekerja sokongan perkeranian, perkhidmatan dan jualan, kemahiran dan pertukangan yang berkaitan serta operator mesin, loji dan pemasang.

iii. Pekerja kurang mahir

Pekerja asas.

11. Nilai harta tetap

Harta tetap meliputi semua barangan, baru atau terpakai, aset ketara atau aset tidak ketara yang digunakan secara berulang atau berterusan yang mempunyai hayat produktif lebih daripada setahun. Ia termasuk tanah, bangunan dan struktur, alat pengangkutan, komputer dan '*peripheral equipment*', mesin, peralatan serta perabot dan pemasangan lain. Nilai harta tetap awal dan akhir bagi tahun rujukan 2015 adalah berasaskan nilai buku bersih. Pembelian, pindaan dan pembaikan besar atau perbelanjaan modal pada tahun berkenaan dikira pada nilai kos sebenar yang dibayar. Nilai harta tetap yang dijual dalam tahun semasa juga dikira pada nilai sebenar.

12. Pembundaran Penjumlahan komponen mungkin berbeza dengan angka jumlah kecil atau besar disebabkan pembundaran.

13. Kadar pertumbuhan tahunan dikompaun (CAGR) Pengiraan kadar pertumbuhan tahunan dikompaun (r) adalah berdasarkan formula berikut:

di mana r ,

1. Scope and coverage

The census covered all registered establishments engaged in **arts, entertainment and recreation services** which included main activities as follows:

- i. Creative, arts and entertainment activities;
- ii. Museums, amusement and cultural activities; and
- iii. Sports and recreation activities.

Overall, coverage of the census for arts, entertainment and recreation services was 38 industries at 5-digit level under the Malaysia Standard Industrial Classification (MSIC) 2008 Ver.1.0. The complete lists of industries are shown in **Appendix**.

2. Source of frame

The main source of establishment frame is obtained from Companies Commission of Malaysia (CCM), Local Authorities (PBT), The Registry of Societies Malaysia (ROS), Cooperative Commission of Malaysia (SKM), Ministry of Youth and Sports and other sources.

The frame is updated annually to take into account new establishments and to record any changes in the status of the establishments such as closed down, not in operation, changes in activities or addresses to make sure the information in the frame is the latest update.

3. Type of business activity

The type of business activity refers to both principal and secondary activities. The principal activity refers to the activity to which the establishment devoted most of its resources or to which it contributes the largest income. Secondary activities are defined as those incidental or ancillary to the principal activity. The classification of the industry of the establishment is based on the principal activity and is in accordance to the **Malaysia Standard Industrial Classification (MSIC) 2008 Ver.1.0**. The MSIC 2008 conforms to the International Standard Industrial Classification of All Economic Activities (ISIC), Revision 4, United Nations, with modifications to suit local conditions.

4. Concepts and definitions

The definition of arts, entertainment and recreation services adopted in this publication is based on the recommendations of the MSIC 2008 Ver. 1.0:

Arts, entertainment and recreation services includes a wide range of activities to meet varied cultural, entertainment and recreational interests of the general public, including live performances, operation of museum sites, gambling, sport and recreation activities.

i. Creative, arts and entertainment activities

This activity includes the operation of facilities and provision of services to meet the cultural and entertainment interests of their customers. This includes the production and promotion of, and participation in, live performance, events or exhibits intended for public viewing, the provision of artistic, creative or technical skill such as activities of sculptors, painters, cartoonists and etc., activities of individual writers, including activities of independent journalists and restoring of works of arts. This activity also includes activities of producers or entrepreneurs of arts live events, with or without facilities.

ii. Museums, amusement and cultural activities

This activity includes the operation of museums of all kinds, botanical, zoological, also including activities of recreation parks and beaches and cyber cafe/internet centre activities.

iii. Sports and recreation activities

This activity includes the provision of sport activities, activities of sport teams or clubs primarily participating in live sports events, independent athletes engaged in participating in live sporting or racing events. This activity also included sports trainers providing specialised services to support participants in sports events or competition, operators of arenas and stadiums, other activities of organising, promoting or managing sports events and other sport

activities. Gambling and betting activities such as sale of lottery ticket, operation of casinos and gambling machines are also included in this activity.

5. Reporting unit

The number of establishments reported in this publication were different from preliminary data published in the Economic Census 2016 Establishment Statistics. The difference was due to the latest analysis of branches status, reclassification of industry and operational status of the establishments.

The reporting unit for this Census is the **establishment**. An establishment ideally defined as “an economic unit that engaged in one activity, under a single legal entity and operating in a single physical location”. Each establishment was assigned an industry classification based on its principal activity and not to that of its parent company.

Each branch of the multiple organisation has branches in different locations of conceptually treated as the different organisation. The establishment was requested to give separate returns for each activity in terms of value. However, if in practice, the accounts were centrally kept such that it was not possible to obtain separate data for each individual unit or branch. The entity or enterprise was treated as a single reporting unit and allowed to submit a consolidated questionnaire covering all units or branches

6. Value of gross output

The value of gross output is defined to include the following items:

- Revenue from services provided
- + Income from the sale of tickets/entrance fees
- + Income from membership fees
- + Income from recreational activities
- + Income from gambling and betting activities
- + Income from consulting services
- + Rental income received except land

- + *Income from management services*
- + *Commissions and brokerage earned*
- + *Research and development expenditure (in-house)*
- + *Other operating income*
- + *Value of goods sold in the same condition as purchased*
- *Value of goods purchased for resale in the same condition as purchased*
- *Payment for winning prizes/rebates*

7. Value of intermediate input

Effective 2012, research and development expenditure has been removed from calculation of intermediate input and treated as capital asset in line with the recommendation of System of National Accounts (SNA) 2008. The value of intermediate input is defined to include the following items:

- Excavation expenses of museums/historical objects*
- + *Conservation expenses of museums/historical objects*
- + *Cost of exhibition and display*
- + *Purchase of animal feed*
- + *Payments for repairs and maintenance*
- + *Expenditure for stationery, office supplies and others*
- + *Purchases of transport services*
- + *Travel and entertainment expenses*
- + *Expenditure for electricity, water, fuel, lubricants and gas*
- + *Accounting, secretarial and audit*
- + *Legal and other professional services fees*
- + *Management fees*
- + *Commissions and agency fees*
- + *Telecommunication, postage and printing cost*
- + *Advertising, marketing and promotion*
- + *Insurance premiums except workers' compensation work*
- + *Payments for security services*
- + *Rental payments exclude rent for use of land*
- + *Other operating expenditure*
- + *Opening stock*
- *Closing stock*

8. Value added

Value added is the increment to the value of commodities and services contributed by the establishment. This value is derived as the difference between the value of gross output and value of intermediate input.

9. Number of persons engaged

Number of persons engaged covers all persons engaged during December or the last pay period of the reference year. The number of persons engaged was classified under the following categories:

i. Working proprietors and active business partner

This category refers to all individual proprietors and partners, part-time or full time, who are actively engaged in the work of the establishment. It therefore, excludes silent and inactive partners.

ii. Unpaid family workers

This category encompasses all persons (full-time or part-time) in the household of the owners of the establishment who perform a specified job and work for a minimum of one third of the normal working time of the establishment but do not receive regular payment, either in cash or in kind for work done. Such workers generally receive food, shelter and other support as part of the household of an owner but this would continue whether they worked in the establishment or not.

iii. Paid full-time employees

It refers to all paid workers who work for at least 6 hours a day and 20 days a month.

iv. Paid part-time employees

It refers to all paid workers who work for less than 6 hours a day and/or less than 20 days a month.

10. Category of skills

Category of skills has also been categorised according to Malaysia Standard Classification of Occupations 2013 (MASCO) as follow:

i. High-skills workers

Managers and professionals, researcher, technician and associate professionals.

ii. Semi-skills workers

Clerical support, service and sales, craft and relates trades workers and plant and machine operators and assemblers.

iii. Low-skills workers

Elementary workers.

11. Value of fixed assets

Fixed assets cover all goods, new or used, tangible or intangible and used repeatedly or continuously that have a normal economic life span of more than one year. This included land, buildings and structure, transport equipment, computer and peripheral equipment, other machinery, equipment and furniture and fittings. Value of fixed assets as at the beginning and end of 2015 was based on net book value. Purchases, alterations and major repairs or capital expenditure during the year were valued at actual costs incurred. Value of fixed assets sold during the year refers to the realised value.

12. Rounding

The sum of the component figures may not tally with the sub-total or total figures due to rounding.
